Dear Mr. Dalzell:

Over the last year, the Company and Union met as part of an effort to identify and implement improvements to the Apprentice Lineman program as well as improving the process to staff the entry level positions in GC Line and Electric T&D Departments.

This agreement is intended to address resulting modifications to the Electric Line Assistant (ELA) classification (Letter of Agreement 16-10) and to the Electric T&D Line of Progression (Letter of Agreement 13-27).

Upon the execution of this agreement, employees hired into the Electric Line Assistant Classification (51863059) will no longer require 12 months in the position to be considered a next lower classification to the Pre-Apprentice Line Worker (PALW) position (which is being eliminated).

The Company and Union agree that employees hired into the Electric Line Assistant classification who complete at least six months in the classification will now be eligible to bid as a next lower classification to the Title 200 Apprentice Lineman position within his or her current bidding area only. Completion of 12 months in the classification will be required to be considered a next lower bidder to an Apprentice Lineman position outside of his or her own bidding area.

As such, the Line of Progression will be changed as follows:
