Dear Mr. Dalzell:

The parties have discussed moving various Title 300 classifications into the Line of Progression of the Gas Control Technician and the Apprentice Gas Control Technician in Gas System Maintenance. The Company proposes pursuant to Section 205.5 of the Agreement to modify the Line of Progression for the Gas Control Technician and the Apprentice Gas Control Technician in Gas System Maintenance. The employees in the Title 300 classifications moved into the Line of Progression will be considered Subsection 205.7.c bidders. The revised Lines of Progression table for the classifications are as follows:
