Dear Mr. Dalzell:

Ray Griesner is a Title 200 Unassigned Lineman headquartered in the Selma Service Center. Prior to bidding to the Selma Service Center as a T200 Apprentice Lineman effective February 6, 2006, Mr. Griesner was a GC Apprentice Lineman. Since Mr. Griesner bid into the 1101 Apprentice Lineman classification after the effective date of Letter Agreement 05-17-PGE, he is required to spend two years in the bidding area as a Lineman before his bids will be considered under the provision of Sections 205.7, 305.5 or 305.7 of the Agreement.

The Company proposes the following placement pursuant to Section 205.19. Mr. Griesner has expressed a desire to return to General Construction as a GC Lineman. There is a shortage of Journeyman Linemen in the Fresno General Construction Line Department, and the local General Construction supervisors are supportive of the proposed return of Mr. Griesner to General Construction as a GC Lineman. The Selma T200 Electric Distribution Supervisor and Business Representative, Mike Grill, are also supportive of the move.

The effective date of the change will be a mutually agreeable date after this agreement is signed. Thereafter, Mr. Griesner will not have his bids considered under the provision of Sections 205.7, 305.5 or 305.7 of the Agreement until September 11, 2009 when he will complete two years as a Lineman.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
