Gentlemen:

Stanislaus Powerhouse is scheduled for shutdown on October 31, 1962 and will start up again in early 1963 as an unmanned powerhouse.

Concurrent with the shutdown of Stanislaus Powerhouse, Company will place in service the new Angels Operating Center. Company, therefore, proposes to establish the classification of First Operator, Three Shift Hydro Plant, Schedule I, at this location.

Furthermore, Company proposes to fill vacancies created at Angels with personnel from Stanislaus Powerhouse without reference to the bidding procedure as follows:

Mr. C. P. Fisher, Station Attendant at Salt Springs, who also has 206.9 rights to First Operator, also has indicated he is not interested in these First Operator positions.
