Dear Mr. Dalzell:

Company and Union have discussed the relocation of Operating Clerical employees who support Electric Operations from 1919 Webster Street in Oakland to the Bishop Ranch facility in San Ramon. The number of Operating Clerical employees needed to staff the San Ramon facility will be at least equivalent to the number of employees impacted by this move. The Company plans to begin staffing Operating Clerical positions in San Ramon beginning in July 2013.

Pursuant to Section 19.12 of the Clerical Agreement, the parties discussed the following process to facilitate the relocation of Clerical employees currently supporting Electric Operations at 1919 Webster Street.

- Company will establish New Jobs at a Headquarters at the Bishop Ranch, San Ramon location in accordance with Subsection 18.4(h).
- Impacted Operating Clerks will be given Section 19.1 notification as soon as possible after the execution of this agreement.
- Along with the 19.1 notification, Company will perform an interest check with each of the impacted Operating Clerks to determine their interest in the following options:
 1. Accept an Operating Clerk vacancy in San Ramon
 2. Accept Section 19.7 layoff with severance, or
 3. Elect to pursue Title 19 process at a later date
- As part of the interest check, the impacted Operating Clerks will be offered the following vacancies in regular positions that have been placed on hold:
 - 3 – Operating Clerk positions at Oakport
 - 1 – Operating Clerk at SF Division

Once the interest checks are completed, the parties will meet again to discuss next steps.
