Gentlemen:

Mr. Jerry Tomblin, a Transmission Mechanic at Pipeline Operations headquarters in Barstow, has requested consideration for a hardship transfer to a Pacific Gas and Electric Company facility near Red Bluff. Mr. Tomblin's wife and family have relocated to Red Bluff so that Mrs. Tomblin can care for her ill father.

Currently, Mr. Tomblin is commuting back and forth from Red Bluff to Barstow. Pipeline Operations is in the process of requesting approval to establish another Transmission Mechanic position at Willows which is within commute distance of Red Bluff. However, this approval process will take five to six weeks. In the interim, Pipeline Operations would be willing to create a temporary Transmission Mechanic position at Willows and place Mr. Tomblin in it on a temporary basis. They would only be willing to do so, however, if they did not have to pay the expenses normally associated with a temporary assignment. Mr. Tomblin has stated that expenses are unnecessary since the job in Willows will allow him to live with his family during the week instead of staying in Barstow. Attached is a copy of Mr. Tomblin's waiver for temporary living expenses.

In view of Mr. Tomblin's situation, we propose to place him in the temporary job, without expense reimbursement, in accordance with provisions of Section 201.13, and then, if the permanent position is authorized, place him in it under Section 205.19. Currently, Mr. Tomblin is the only employee with an active prebid on file






