Gentlemen:

We propose, pursuant to Subsection 202.16(b) of the Company-Union Physical Agreement, to permanently change the hours of work for the employees at the Petaluma Garage in North Bay Division.

Attached is a letter dated March 21, 1984 which established a temporary change of hours for the Petaluma Garage personnel. At the time of the change, the hours were from 4:00 p.m. to 12 midnight, Monday through Friday. Those hours were changed to 4:00 p.m. to 12 midnight, Monday through Thursday, and 9:30 a.m. to 6:00 p.m. with a one-half hour lunch between 1:30 p.m. and 2:00 p.m. on Friday.

The initial change was made to allow garage personnel to deal with vendors. During the period of the temporary change, several benefits were realized, including closer communication with outside vendors, farm-out repair jobs and local supervision.
