## SACRAMENTO VALLEY REGION LABOR-MANAGEMENT MEETING

### 1. Frequency of Meetings

Meetings shall be scheduled every quarter for a timely review of topics and information.

### 2. Attendees

Company and Union shall each select one person to chair and coordinate the quarterly meetings. Both parties shall each select a person from each of the newly formed divisions to attend the Regional meeting. Additionally, Union may select a participant from each department supervised on a regional basis, such as Materials, Substation, Gas Load Centers, etc. The Union's Business Representatives and Company's Personnel Managers shall also be participants.

Bargaining unit participants shall schedule necessary time off with their immediate supervisor. Time necessary for traveling and attendance, including preparatory meetings, shall be considered as time worked and Sections 201.7 through 201.12 of the Physical Agreement shall apply.

### 3. Agenda Items

Items generic of a common interest to Company and Union that are not currently in the Grievance Procedure may be placed on the Agenda. Both parties should submit their agenda items with as much advance notice as possible.

### 4. Communication

A jointly prepared detailed resume shall be distributed to each participant of the meeting and to each member of the local labor-management committees in the Region. Further distribution is to be determined independently by both Company and Union.

### 5. Location of Meeting

The meeting should be held at a central location for reduced travel time for the majority of the group. However, the location may be rotated by mutual agreement.
