Gentlemen:

Company proposes pursuant to Subsection 202.16 to establish a new shift at the Dado Street Materials Facility in San Jose. The purpose of this change is to create a shift stagger that will allow a reduction in turnaround time for field materials delivery from 24-48 hours to 8-12 hours. This will substantially assist our operating departments in meeting their customer obligations.

There is no change proposed in the total manpower level or the current mix or number of individual classifications at the headquarters.

INITIAL STAFFING:

The two classifications on the new 11:00 p.m.-7:00 a.m. shift will be Leadman Drivers. These would be filled by volunteers from the existing group of Leadman Drivers. One volunteer is secured and filling the other is expected not to be a problem. Company does not anticipate forcing non-Volunteers to fill out the shift.

SHIFT RELIEF:

In the event of an unexpected absence on the shift, necessary overtime will be used to cover same, by extending the workday of qualified employees on the 2:30 p.m.-11:00 p.m. shift. In the event said personnel are not available, the facility will use their normal Emergency Overtime List pursuant to Title 212 of the Agreement.

In the event of an absence of 5 days or more, (e.g. vacation) upgrade to cover the vacant shift will come from the normal source of senior qualified pre-bidders in the headquarters.

SHIFT PREMIUM:

The normal application of shift premiums will apply in this case.
