Gentlemen:

Pursuant to Section 205.19 of the Physical Agreement, Company proposes to change the headquarters of all Routine Plant Clerks and Utility Plant Clerks in the Nuclear Power Generation, Nuclear Engineering and Construction Services Department (NECS), to Diablo Canyon Power Plant, Administrative Services Department.

This new organizational alignment will allow improved coordination of administrative services at the DCPD site while still guaranteeing continued administrative support to OPEG, GC and NECS Cost/Scheduling.

This proposal will affect the application of Titles 202, 205, 206, 208, and 212 of the Physical Agreement; therefore, Company proposes the following:

1. Pursuant to Section 202.16(b), regular hours of work for NECS clerical employees, except the clerk responsible for mail duties, may be from 7:00am to 3:30pm. The regular hours of work for the mail processing clerk are to be 6:30am to 3:00pm. (Reference Letter Agreement #88-04-ES)
2. As a result of this agreement, the pre-bid and transfer codes for Utility Plant Clerk, Routine Plant Clerk, and First Plant Clerk positions at NECS will be replaced by their respective DCPD codes. All pre-bid and transfer

applicantiions for the above mentioned NECS classifica-
tions will be cancelled. Notification of this
cancellation will be sent to all current pre-bid and
transfer applicants.

3. Pursuant to Letter Agreement #R2-88-84-PGE the following will apply: For the purposes of Title 206, an employee affected by this agreement cannot displace an employee outside of NECS. Likewise, an employee outside of NECS cannot displace an employee affected by this agreement. This provision will not affect those employees in the Utility Plant Clerk classification. This separation of the application of Title 206 will remain in effect until December 31, 1990.
4. NECS Clerical employees are to be covered by the same prearranged and emergency overtime administrative procedures as DCPD clerical employees.

This matter has already been discussed with the local Business Representative.

If you are in accord with the foregoing agreement thereto, please so indicate in the space provided below and return an executed copy of this letter to the company.
