Gentlemen:

Company proposes a supplemental open enrollment limited to medical plans and employees/retirees residing in the Grass Valley area who are currently enrolled in the Blue Cross Prudent Buyer Plan.

Company has recently been made aware of the fact that Blue Cross of California has terminated the Prudent Buyer Plan participating hospital agreement with Sierra Nevada Memorial Hospital. Although this termination was technically effective on December 31, 1991, Blue Cross will continue to provide benefits to PG&E members at the Prudent Buyer Plan level (100% of covered services) until April 1, 1992. Subsequent to April 1, 1992 all Prudent Buyer Plan members must identify alternative participating hospitals in the area in order to receive the Prudent Buyer level of covered services. Alternative participating hospitals within 30 road miles of the Grass Valley area include Auburn Faith Community Hospital in Auburn, and Rideout Memorial Hospital in Marysville.

Company is concerned that the lack of timely and direct communication from Blue Cross on this matter may have precluded Prudent Buyer members residing in this area from making a fully informed decision during the recently conducted open enrollment period. Accordingly, Pursuant to the eligibility provisions of Exhibits G (Foundation Health Plan) and M (Health Net Plan) of the 1991 Medical, Dental and Vision Agreement, Company proposes a limited medical plan open enrollment for employees and retirees residing in the Grass Valley area who are currently enrolled in the Blue Cross Prudent Buyer Plan. This open enrollment is to be without precedent, and offered strictly in acknowledgement of the fact that PG&E Prudent Buyer members may have elected other health care options had Blue Cross communicated this change in a timely fashion.


Under this proposal, the limited open enrollment will occur during the time period of March 9 through March 18, 1992. During this period employees and retirees who reside in the Grass Valley area and are presently enrolled in the Blue Cross Prudent Buyer Plan may elect to convert medical coverage to the Foundation Health Plan, the Health Net plan or to remain as members of the Blue Cross Prudent Buyer Plan. Any changes in medical plans elected during this limited open enrollment will become effective on April 1, 1992.

If you are in accord with the foregoing and attachment and agree thereto, please so indicate in the space provided below and return one executed copy of this letter to the Company.
