Gentlemen:

A Letter Agreement 94-53 Committee was established at Diablo Canyon to address issues that arose when the tool organization was consolidated under Materials Services. Following the consolidation, the tool rooms were combined to increase efficiency. The Mechanical, Electrical, and Instrument and Controls Tool Clerks are assigned to the same tool rooms and perform the same task, yet have different job descriptions and training. This proposal was developed by the Committee to address the need for a new Tool Clerk job description which more accurately reflected their job duties.

0336 TOOL MAINTENANCE CLERK (MECHANICAL) (DCPP)
0334 TOOL MAINTENANCE CLERK (INSTRUMENT MAINTENANCE (DCPP)
0332 TOOL MAINTENANCE CLERK (ELECTRICAL) (DCPP)

An employee who maintains the inventory of tools, consumables, weld rod, and measurement and test equipment in the assigned tool room. Inventory maintenance includes issuing and receiving materials, ordering replacement stock, routine inspection and cleaning of equipment and facilities related to tool control, repair of damaged tooling, calibration of torque wrenches and crimpers, operation and maintenance or welding rod ovens, and the record keeping associated with each of these activities. May be required to operate a forklift in the performance of such duties.

The <u>Next Lower Classifications</u> and <u>Same or Higher Classifications</u> for the three classifications listed above remain unchanged.
