## Gentlemen:

In conjunction with the impending sale of the Company's fossil and geothermal generation facilities, voluntary severance (VSI) was offered to impacted IBEW physical employees located at the Moss Landing and Morro Bay Power Plants to minimize the impact of the anticipated displacement and demotion process that may occur later in the year. The VSI consideration period expired on February 27, 1998.

At that time, voluntary severance was offered to Mr. Gregory Cherry, Welder. Mr. Cherry elected not to participate in the VSI Program during the original consideration period. Since that time, Mr. Cherry has asked that an exception be made - to allow him to elect voluntary severance and to resign from the Company.

The Company proposes to allow Mr. Cherry to elect voluntary severance at this time since the circumstances under which the Voluntary Severance Incentive Program was offered still exists.

As with all employees who participate in the Voluntary Severance Incentive Program, Mr. Cherry will not be able to revoke his decision to participate in the VSI Program.

The resignation date for Mr. Cherry will be within a week of the signing of this letter agreement. The additional time worked will be counted as credited service in calculating his new VSI benefit.

This Letter Agreement is specific to the business situation described above and is non-precedential.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
