Gentlemen:

This letter supersedes our proposed letter agreement of May 29, 1980, on the same subject.

As you know, more and more of the automotive equipment that the Company buys has metric fasteners which, in turn, requires our Equipment Mechanics to have wrenches with metric sizes as opposed to inches. The Company, therefore, proposes to add the following to the negotiated tool list for Equipment Mechanics:

1/2" Drive Standard Sockets	(16)	9 MM to 32 MM
1/2" Drive Deep Sockets	(5)	14 MM to 27 MM
3/8" Drive Standard Sockets	(11)	9 MM to 19 MM

The Sears Roebuck catalog price for the above tools is \$241.63, including 6% sales tax. These are good, not premium, quality metric tools.

In return the Company proposes to make a one-time payment to each Apprentice Equipment Mechanic, Equipment Mechanic and Subforeman, including General Construction equivalent classifications, of \$250 on March 1, 1981,
