#### Gentlemen:

Pursuant to Section 202.16(b) of the Physical Agreement, Company proposes to establish a 4-day, 10-hour shift schedule for Humboldt Division's five night shift Garage employees in Eureka. We would like this to begin on a trial basis on the first Monday after an Agreement is signed and continue for 8 months. This specific agreement will be in accordance with the Generic Four-Day, Ten-Hour Agreement (86-155-PGE) except as listed herein.

#### WORK WEEK

The work hours will begin at 1530 hours and end at 0200 hours. One unit (3 employees) will be assigned a normal work week of Monday through Thursday, the second unit (2 employees) will be assigned a normal Tuesday through Friday work week. At the end of 4 months, these schedules will be switched.

#### OVERTIME MEALS

The meal provisions of Title 104 shall apply. In no event shall an employee be required to work more than five hours without a meal. If the lunch period is delayed more than one half hour, employees will be paid the overtime rate for work performed in the regular lunch period and may eat their lunch on Company time per Title 202.4.

#### PERSONNEL

All (5) bargaining unit personnel in the night shift will participate in this schedule (see attached). Persons in like classifications wishing to exchange their scheduled work week from one unit to the other may do so on a mutually agreeable basis with good cause and management's concurrence.

### **CANCELLATION**

Either the Company or Union reserves the right to return to the five-day, eight-hour shift schedule by giving 15 days notice.

The intent of this test is to continue providing five day a week service to our customers, while reducing maintenance expenditures, increase productivity and enhance the morale of the garage employees. There is no intent to extend this 4/10 schedule into a regular 5/10 schedule. However, that does not preclude the scheduling of prearranged overtime as required.
