Gentlemen:

Upon execution of this letter agreement, Company proposes to establish a joint committee to test and evaluate various workstation elements to be incorporated in the Company's new Call Centers.

The Company will establish workstations at the San Jose Division Office for a work group consisting of a supervisor and 15-20 Service Representatives. The purpose of the workstation test is to identify the various workstation elements (keyboard variations, ergonomic chairs, task lighting, etc.) to be implemented in the typical call center workstation.

The Joint Committee will have the following responsibilities:

- 1. Employee Communications
 - a. Communications on Workstation Project to Customer Services employees systemwide: may include use of written and formal or informal stand-up communications. Written communications will be jointly prepared. The text/agenda for formal stand-up communications will be jointly agreed to.
 - b. Feasibility of Employee Tours of Proposed Workstations.

- 2. Workstation Accessories
 - a. Identify accessories that will be incorporated in a typical workstation.
 - b. Design selection process: typical workstation, optional accessories.
- 3. Staffing
 - a. Method of selecting employees for San Jose Division office test site.
- 4. **Benchmarking Tours**
 - a. Method of selecting employees for benchmarking tours to other organizations.
- 5. Evaluation
 - a. Identify length of test period.
 - b. Determine evaluation process(es) used with an emphasis on getting employees' suggestions on improvements to workstations and other issues within the work environment.

The Committee will consist of an equal number of management employees and employees selected by Local 1245. Union committee members time spent during joint committee meetings and expenses incurred as a result of meetings will be paid for by the Company.
