Gentlemen:

This letter cancels and supersedes our letter to you, dated January 26, 1989 to change the Fresno candidate from Ed Espinosa to Joe Brunkhorst.

Company intends to establish the recently negotiated Telecommunication Crew Foreman classification in locations throughout the system. In order to accomplish this, Company would like to establish the positions by reclassifying the positions of successful bidders from the Telecommunication Technician classification. However, because of control number restrictions, in certain locations, filling these positions in accordance with the provisions of 205.4(h) could force the relocation of Technicians from the headquarters where the Crew Foreman positions are established and possibly jeopardize the establishment of these initial positions.

In order to avoid possible severe displacements, Company proposes, pursuant to 205.19, to fill the initial positions with Telecommunication Technicians headquartered in the designated locations. Once the initial positions have been filled, established Crew Foreman vacancies will be filled in accordance with Section 205.7. Following is a list of the locations Company proposes to establish the new classification and the names of the designated employees to be placed in the newly established classifications:
