Grievance Issue: A Lineman received an Oral Reminder allegedly without just or sufficient cause.

Facts of the Case:

The grievant was at a stand-up meeting at which time he brought up a personal issue with the supervisor which had already been discussed with the grievant. The supervisor told the grievant that the issue was already discussed and the matter is closed. The grievant wanted to attend the Region Ideas in Action Promotion which was being held in another yard, and the supervisor told the grievant that operational needs prohibited him from allowing the grievant to attend.

The grievant left the meeting without permission before the meeting was over. The grievant was confronted by the supervisor in the yard, and the grievant stated he was sick. The supervisor told the grievant to bring proof of ilness if he was sick. The grievant then drove from the yard, laying rubber after leaving the gate.

The grievant returned to the yard later that day with a note from his doctor prescribing one week off.

The grievant was issued an Oral Reminder for disrupting a meeting, leaving a meeting without permission and speeding in the yard.

Discussion:

The Committee discussed the issues surrounding this case and the incident which resulted in the Oral Reminder. It appears from the testimony in the report that the meeting was already loud and boisterous before the grievant interjected his remarks about the Region Program. It is unclear whether the grievant exited the yard in an unsafe and reckless manner. The Committee does not agree that the grievant left the meeting before it was over and without permission.

Decision:

The Committee agrees that the Oral Reminder should be modified as per the attached to reflect only that the grievant left the meeting without permission.

This case is closed without further adjustment.
