Subject of Grievance

Alleged assignment of Senior Meter Reader work to Meter Reader in DeAnza Division.

Discussion

The case concerns whether Energy Cost Inquiry (ECI) re-reads on a continuous basis is Senior Meter Reader Work.


An identical case had been referred from Fact Finding to Pre-Review Committee on February 1, 1990. The Pre-Review Committee (PRC #1400) recommended settlement based upon the Company offer at the Local Investigating Committee. (See attached PRC #1400).

Therefore, pursuant to PRC direction, this case is settled based on the following:

The Company may continue to use meter readers for ECI reads, however, when performing ECI reads, they will be upgraded to Senior Meter Reader.


Decision


