Subject of the Grievance:

This case concerns a Working Foreman A and a MEOA who were released from a prearranged overtime assignment at 9:00 a.m. Another MEOB reported for a prearranged overtime assignment at 7:00 a.m. and worked until 5:30 p.m.

## Facts of the Case:

A Working Foreman A and a MEOA reported for prearranged overtime at 12:30 a.m. and were released at 9:00 a.m. As the MEOB reported for prearranged overtime at 7:00 a.m. that same morning and worked until 5:30 p.m.

The MEOB operated a loader for approximately three to four hours and was upgraded to MEOA for four hours as an outcome of the LIC. Another Working Foreman A from another job site was sent to the one in question to finalize the clean-up. There was also a contract labor crew at the job site.

## Discussion and Decision:

Company and Union discussed the necessity of having a Working Foreman A at the job site. It was apparent that Company supervision did in fact feel the need as they sent a Working Foreman A from another job site over to the site in question. It was also apparent that since the MEOB operated the loader for a period of time, that a higher classification was in fact needed.

Company agreed to pay the Working Foreman A from his release at 9:00 a.m. through 5:30 p.m. as the Working Foreman A could have supervised the contract crew and operated the equipment himself. Working Foreman A's can perform all work below their classification. The MEOB will keep the four-hour upgrade outlined in the LIC because he actually performed the work.

This case is considered closed and should be so noted in the Joint Grievance Committee minutes.
