#### Subject of the Grievance

These cases all concern assignments made to various electrical journeyman classifications. The assignments either anticipated or did involve the performance of switching. Some assignments were during straight time and others during overtime. The grievances allege that some classification other than the one assigned should have performed the work.

#### Discussion

These cases arose as a result of an agreement reached between the parties during the 2000 General Negotiations, which is documented in Item 2g of the cover letter dated October 27, 1999. With respect to switching assignments at substations, Item 2g states:

"The Company and Union agree to establish an interim committee to determine the need for training, certification, and ongoing re-certification of classifications involved and agree with the concept that the following classifications, when qualified and depending on the type of switching involved may have switching as a common duty, including switching performed on overtime, replacing existing protocols.

- Troublemens
- Transmission Troublemens
- Electrician (Title 200 and 300)
- Electrical Technician (Title 200 and 300)
- System Operator/Relief Operator/Roving Operator"

The PRC is in agreement that all of the above classifications are qualified to perform switching at substations and that Company need not follow any specific pecking order for such assignments whether on straight time or overtime.

Decision


The PRC is in agreement to close all of the above grievances without adjustment as no violation occurred. Further, the parties agreed to expedite the development and implementation of any necessary training.
