Such adjustment will be at the overtime rate for the excess time that the scheduled lunch hour exceeded one hour and will be applied to the 30 calendar days prior to the date the employee's scheduled lunch period was changed to one hour.

The cases will be considered closed following payment of the retroactive adjustments provided for above.
