The above subject grievances, both of which concern the bypass of Linemen from San Francisco Division, were recently referred by your Committee to the Review Committee. At the Review Committee meeting of February 4th, these grievances were discussed and the decision which will follow was agreed to.

Both of the grievances result from the Division's allegation that inasmuch as the grievants had not completed 30 months of Apprentice Lineman training, the grievants were "...not qualified Linemen, due to insufficient training." After discussion of these cases, it is the Review Committee's decision that both of the grievants were acknowledged as qualified Linemen upon their appointment to Lineman vacancies in the San Francisco Division, and as there was no proof offered of their present lack of qualifications, the Review Committee cannot sustain the Division's action.

As a result of this decision, the grievants shall be assigned to Lineman vacancies in the San Rafael headquarters of the North Bay Division, effective February 10, 1964. They have been informed, at your office's request, that they are to report to Mr. L. O. Robertson, District Electric Superintendent, at the Service Center at 8:00 AM on that date.

It will be in order for the receiving Division to prepare the necessary DMA's, appointing the grievants to such vacancies as of the effective date.


