The Review Committee discussed the above-subject grievance at its last meeting. We are returning the grievance to your Committee for further discussion and disposition in accord with the following:

Inasmuch as the Local Investigating Committee has agreed that the grievant is not presently qualified to step into the position and perform the work required and because the appointee is, this case will be considered closed.

This decision must follow notwithstanding the fact that the appointee has less seniority than the grievant and had received training that qualified him for the vacancy while the grievant did not. This is so because the appointee worked in the same department and headquarters where the vacancy occurred and was properly temporarily upgraded to that position on various occasions in the past while the grievant did not work in the same department and headquarters where the vacancy occurred and was not in line for such temporary upgrades.

This case is considered closed and should be so noted by the Local Investigating Committee.
