On May 11, 1974, you wrote to me regarding the current status of the above Review Committee file. With respect to that case, the following action has been taken:

On March 4, 1974, the Union notified the Chairman of the Review Committee, in writing, that we were withdrawing the case from the active files without prejudice (correspondence enclosed).

Business Representative Orville Owen was immediately notified by telephone of the disposition of the case and in addition was sent a copy of the withdrawal letter. Subsequently, Mr. Owen informed this office that you, the grievant, had been notified of the final disposition of the case.

Union's decision to withdraw the case was reached after considerable discussion and analysis of the facts and circumstances surrounding the grievance. Our analysis led us to the conclusion that to arbitrate this issue would probably be futile. In addition to our own conclusions in the matter, we sought and received advice from Counsel in support of this decision. These reasons, coupled with our obligation to insure the continuing health and integrity of the grievance procedure, including arbitration, formed the basis for Union's withdrawal.
