San Francisco Division Grievance No. 2-906-84-6  
Review Committee File No. 1579-84-14

This case concerns the awarding of Senior Meter Reader positions in San Francisco Division. On December 30, 1983, the Company filled three positions in San Francisco District.

The Union argued that no Senior Meter Reader jobs should be filled since the Company/Union Meter Reader Committee was still negotiating the Line of Progression for the classification.

This case was referred to the Review Committee and then to the Meter Reader Negotiating Committee pursuant to Step Five B(iv)(4).

The Meter Reader Negotiating Committee agreed on the attached Line of Progression for the Senior Meter Reader classification. The Committee also agreed to allow any employee whose name appears on the attached list and who previously held the classification of Meter Reader but was reclassified to Service Representative between December 31, 1982 and October 1, 1983 to be considered as a qualified Section 18.8(b) bidder without regard to the two-year minimum Meter Reader experience requirement.

The Division should review the Senior Meter Reader job awards to determine if any employee was improperly bypassed. In the event one of the employees contained on the list still wishes to be awarded a Senior Meter Reader position, the Division should make the proper adjustment.

On the basis of the above, the Review Committee agrees to close this case.
