

## Ad Hoc 88-9 and 88-10

The above-referenced cases were referred to Ad Hoc Negotiations as Ad Hoc 88-9 and 88-10. The cases concerned maintenance and repair of computers, and telephone station moves, adds and changes. On August 3, 1989 an Ad Hoc Committee met to discuss the cases. Based on these discussions, the Ad Hoc committee agreed to return the cases to the Review Committee for settlement in accordance with the following guidelines:

- RC 1678
  - Replacement of interface cards by users where voluntary and where no assistance or training is required is a *de minimis* assignment pursuant to Section 7.2.
  - Personal Computer repair or replacement beyond that outlined above is work that belongs within the bargaining unit to technical classifications.
- RC 1669
  - Work currently performed by the exempt Analyst is appropriately non-bargaining unit work except for the actual inputting of commands. Such inputting is bargaining unit work unless it is a *de minimis* assignment.
  - It is recognized that repair work that occurs, such as repair to switches, is to be performed by Telecommunication Technicians unless contracted in compliance with RC 1637 and Letter Agreement 88-104.
