The Review Committee discussed CPEC-36-91-1 and CPEC-20-90-20 (RC# 1727) at the November 21, 1991 meeting. In reviewing the file in CPEC Case #20, it was noted that no Local Investigating Committee report had been prepared. It is recommended that a Local Investigating Committee be formed and a report prepared which addresses questions to be generated by the Clerical Position Evaluation Committee and the following questions from the Review Committee:

1. Do the confirmation documents signed by supervisors Taylor and Casey refer to the additional comments on the non-benchmark duty statement?
2. Whose initials are on the revised non-benchmark statement (PEQ, Section III)?

With regard to CPEC Case #36 (RC# 1728), this case is being returned to:

1. Reexamine and resolve the dispute with regard to lead duties.
2. Review benchmark duty statements which have level B or C judgement factors and compare those to the non-benchmark duty statement of this grieved position.

It is hoped that this case may be resolved by the CPEC after this further review.

These cases are removed from the agenda of the Review Committee.
