Attached is a copy of a letter issued by Russ Cunningham, which states that the in lieu holiday for Veteran's Day, Saturday, November 11, 1989, must be taken before the end of the year. Several of you have already contacted me about this subject.

I spoke with David Bergman and Doris Spingola today about this letter and was informed that a corrected letter was issued by Company several days follow the attached. Unfortunately, I have not received a copy of the correction.

The Physical (103.6) and Clerical (14.6) Agreements state that under these circumstances, an employee is entitled to one additional day off with pay, to be taken in conjunction with the employees next scheduled vacation. If no additional vacation is scheduled during 1989, this in lieu day will carry over to 1990, where it must be taken in conjunction with the first scheduled vacation period. However, it may be taken at any time following the holiday and prior to the next scheduled vacation period with the permission of the supervisor in charge.

This day off should be taken in conjunction with the employee's next scheduled vacation or can be taken earlier with the approval of the supervisor in charge. However, the additional day may not be taken before November 11, and must be taken by the end of the year.

On time sheets and transmittals, this day off should be reported as a holiday with reference to Veteran's Day, November 11.
