





IBEW 1245 Members' Shatter Prior Record — **Submit 13,000+ Proposals** to the PG&E Bargaining **Committee**

Member engagement brings strength to the table

Vacaville - From March 1 to March 31, 2025, IBEW 1245 PG&E members submitted proposals for upcoming PG&E General Negotiations.

Proposals poured in right up until the deadline for submission. The last week of March a mountain of proposals submitted on paper arrived at the Hall along with all of those submitted electronically. The electronic submissions alone eclipsed any known total from past negotiating cycles with PG&E weeks ago. The previous record number was 4,500 from 2016. As of this writing, the counter registers over 13,000 proposals submissions with large piles of paper in the process of being digitized for examination and consideration by the Bargaining Committee members.

The unprecedented number of proposals submitted are a credit to the engagement and participation of all of our PG&E brothers and sisters from across the system. This level of engagement will be critical to what we can achieve at the bargaining table with the company. It will be vital through every step. Every informational meeting, Unit Meeting, Town Hall calls, and most vitally, every ratification vote. Thank you to everyone that submitted a proposal or endorsed one at a Unit Meeting. We are off to a tremendous start. Now the proposal baton is passed to the Bargaining Committee.

STATEMENT FROM BUSINESS MANAGER BOB DEAN

Standing with IBEW 1245's Federal Workers

Vacaville — The recent Executive Order stripping federal employees of their collective bargaining rights is one of several that directly impacts the men and women of IBEW

Under the guise of "national security," some federal agencies have been instructed to cease honoring their bargaining obligations, to stop deducting union dues and to cease grievance proceedings. Unfortunately, IBEW 1245 members at the Western Area Power Administration (WAPA) are included within the Order, and they have been put on notice that their collective bargaining rights are consequently null and void.

Why WAPA? What does it do? Who are 1245's members there? And why does it matter?

Established in 1977 under the Department of Energy, WAPA was created to market and distribute power generated by U.S. Bureau of Reclamation (USBR) projects. WA-PA's Sierra Nevada Region operates California's federally owned high-voltage transmission system, delivering low cost and reliable hydroelectric power to public utilities across California. WAPA plays a critical role in delivering low-cost, renewable energy, reinforcing the benefits of not-for-profit energy distribution over private, investordriven models.

On a nuts-and-bolts level, WAPA delivers power from hydro power plants like Shasta, Folsom, Trinity and New Melones dams to SMUD, the City of Redding, and countless other public utilities and municipalities. Without WAPA, that power could not be transmitted.

IBEW 1245 members at WAPA are Lineman, Electricians, Protection and Communication Craftsmen, and Electronic Equipment Craftsmen who maintain WAPA's facilities and infrastructure. The work they do meets the equivalent annual electrical needs of 650,000 Californians and helps ensure the reliability of this essential energy system.

In sum, their work is fundamental to the sustainability and efficiency of the grid.

And they are also part of the core mission of IBEW, which includes ensuring (1) the accessibility and reliability of electrical power, (2) the safety of our communities and members, and (3) the just compensation and fair treatment of our members in their employment.

Why does all of this matter?

The attack on the collective bargaining rights of our sisters and brothers at WAPA threatens the entire house of labor. This assault is likely the first step of a larger project aimed at crippling the labor movement and stripping millions of unionized employees in both the public and private sectors of their rights.

We all know that absent a collective bargaining agreement, workers are at heightened risk of unfair treatment, and being subject to decisions that are made arbitrarily, with no recourse or due process. The record shows that those who are "at will" (non-union) employees suffer lower wages, poorer benefits, weaker retirement benefits and lower safety standards. Workers are more easily fired without cause.

IBEW 1245 is collaborating with our local, state and national labor allies, both political and legal, to challenge this Executive Order, which we believe is blatantly illegal. We are examining any and all options for recourse. To be sure, other International unions have already stepped into the breach and filed their own lawsuits. And just this week, two Congressmen introduced legislation which would reverse the nullification of federal workers' rights to collectively bargain. But if there's an opportunity for IBEW 1245 to join the fight, we will not stand idly by. We will act.

Our ancestors fought (and died) for the right to form a Union—a group of working men and women standing together to negotiate fair wages, safe working conditions, benefits and a dignified retirement with those in power. They laid the foundation upon which we have grown the various crafts that we represent along with the Union and the collective pride that comes with supporting ourselves and our loved ones and being part of something bigger than ourselves.

Despite these unprecedented times, IBEW 1245 will continue to fight for the rights of our members at WAPA, and for all of our members.

PG&E Shop Stewards Trainings

"You are the shock troops. Without you none of the work we do could get done."

Vacaville — Seventy-two PG&E Shop Stewards from Sacramento and Sierra Division packed the Union Hall for the annual Shop Steward Training. The meeting was one of ten annual trainings being held this year, and coincide with preparations for upcoming 2025 contract negotiations at the company.

IBEW 1245 Business Manager Bob Dean kicked off the meeting saying, "Thank you for being here. Thanks for all the work you do. You are the shock troops. Without you none of the work we do could get done."

IBEW 1245 Shop Stewards are dedicated members who volunteer to uphold and defend the Collective Bargaining Agreement (CBA) or Memorandum of Understanding (MOU) at the work site.

When members have a question about the contract, Shop Stewards are often the first contact they make. When members face disciplinary action, Shop Stewards accompany them, educate them about their rights and make sure due process is followed. When there is an emergency, Shop Stewards relay the message to the broader membership. When there are contract negotiations, Shop Stewards spread the word and turn out the vote.

IBEW 1245 Business Representative Mike Tilden added, "Our Shop Stewards are the backbone of our movement. Our ability to provide training is one of the most valuable components of our jobs as Business Reps."

This year's IBEW 1245 Shop Steward trainings are packed, coming at a time of unprecedented activity.

Negotiations are a major discussion point at every training. Additional themes include Union elections for officers, Advisory Council and delegates to the International Convention, and the many challenges and opportunities facing IBEW 1245.

Dean provides a detailed overview while Senior Assistant Business Managers drill down into specific lines of progression. Business Representatives provide additional training on the nuts and bolts of being a Steward.

Organizers invite stewards to sign up for Emergency Response Teams to be at the ready to mobilize to press for better contracts at the Table or for better legislation in the Halls of the Legislature and in Board

At every session, Brother Dean has emphasized two points, saying, "We are pre-

Building The Brotherhood and Building Power One Story, One Campaign at a Time

DAY 1 — IBEW 9th District Annual Organizing Training

Vacaville, CA — In a first, the annual IBEW 9th District Organizing Training was hosted by IBEW 1245 at the Union Hall in Vacaville!

The two-day event showcased IBEW 1245's extraordinary organizing program that has been the envy of the labor movement. Forty organizers from twenty-two IBEW Locals attended the event

IBEW International Vice President for the 9th District, Dave Reaves, recognized the IBEW 1245 work that has propelled growth and member engagement, and thanked IBEW 1245 Business Manager Bob Dean and the Organizing Team for hosting this year's event and sharing their organizing approach.

Brother Dean and the IBEW 1245 Executive Board welcomed the group. After acknowledging the Executive Board's commitment to investing in organizing and leadership development, Dean declared, "This is a huge, member driven exercise. It helps us by getting our members engaged. We are in the middle of a contract battle with our largest employers, and I already have an army mobilized for that fight."

Senior Assistant Business Manager Al Fortier joined Assistant Business Manager Rene Cruz Martinez and his dynamic team of organizers to lead the training, introducing the attendees to the nuts and bolts of the Organizing Steward program, which has won accolades from sister locals, other affiliates, central labor councils, state labor federations and the International.

The program, a multi-generational, hands-on leadership development initiative, is entering its twelfth year.

Formalized in 2013, the first class was comprised of twenty-eight stewards. Today, more than 125 stewards are active.

Sharing Our Stories

Cruz Martinez kicked off the training saying, "Stories are a crucial way to engage members and invite them to get



involved." Cruz Martinez, a twelve-year IBEW 1245 member who came out of the rank and file and was part of the first class of Organizing Stewards, shared his own story.

"My mother was a garment maker, working 7-to-7 and making less than minimum wage...my dad was a farm worker. I didn't know much about politics or organizing. But I wanted to help people. I started working for PG&E when a co-worker invited me to help knock doors for the "No on Prop 32," an effort to limit unions' ability to participate in politics. My first organizing campaign was Sunoptics, a manufacturing plant. I witnessed how nonunion workers were treated. We won. And I never turned back." Cruz Martinez has been on staff for seven years and leads the organizing team.

"Stories are crucial as we try to engage members and invite them to get involved," he said.

Inviting Members Over and Over — Never Giving Up

Organizer Charlotte Stevens reviewed the structure and roots of the program, emphasizing the importance of building relationships and creating opportunities for members to participate.

"I knew nothing about the union, and I definitely didn't want to go to a meeting. But a co-worker kept asking. I said, 'No.' But she kept asking... I was out of excuses when she invited me to an action instead of a meeting, saying

'Charlotte, Diablo Canyon Power Plant (DCPP) is being shut down...members are going to lose their jobs.' I didn't know what DCPP was, but being laid off resonated with me, so I agreed to attend the action at the state capitol fighting the closure of DCPP in San Luis Obispo. There were so many people standing in solidarity. 1245 and other unions were standing with brothers and sisters losing their jobs. That hit me. I'd been laid off so many times. After eight years of being in the US Airforce, this was a solidarity I'd not seen since my military service. It brought back that sense of purpose we are our brothers' keeper. ... I wouldn't be here had someone not asked me and didn't give up asking me!" said Stevens.

Building an Organizing Culture

Conventional wisdom used to maintain that a union could excel either at representing the contract or excel as an organizing power. IBEW 1245's organizing program sought to do both. The genesis of the IBEW 1245 Organizing Steward program is rooted in two contract fights, NV Energy and PG&E Clerical, during the aftermath of the 2009 recession. Those two successful organizing drives, and a long-term commitment by IBEW 1245's leadership to invest in the next generation of younger members, planted the seeds of the Organizing Steward program.

Self-interest met solidarity, and a passion for making a difference and sharing the union difference was born, one campaign, one contract, one 1:1

conversation, one opportunity at a time.

Local successes provided convincing evidence of the dividends that an engaged and enthusiastic membership provides. IBEW 1245 member organizers developed the reputation of the "first to arrive and the last to leave" across labor councils, state labor federations, and other campaign stops.

After five years of tilling the soil through hands-on fights and formal training, the IBEW 1245 Executive Board institutionalized the program and named it the Organizing Steward program.

"Passion fuels this program and the relationships we have with one another. Tomorrow ninety Organizing Stewards will be coming to the Hall on their day off," said Cruz Martinez.

Organizing, Politics and Solidarity

Organizer Rick Thompson shared, "Just as Shop Stewards defend the contract, Organizing Stewards defend the principles of the Union." The three areas are: organizing, politics, and solidarity.

Politics — While sometimes controversial, politics are a critical part of the work. "What we can't get at the bargaining table, we get at a different arena," said Thompson. In the public sector, elected officials sign off on the CBA/MOU. When we go to the capitol, legislators see us and recognize us," said Thompson.

As a case in point, when PG&E entered bankruptcy, political support was crucial to strengthening and extending our CBA, providing for Gen-

eral Wage Increases (GWIs), preserving medical/benefits, and adding a "no voluntary lay off" clause. In anther example of IBEW 1245 using legislative strength to gain collective bargaining improvements for our members, IBEW 1245 successfully lobbied to amend SB 247, a wildland fire prevention and vegetation management bill, inserting language in the bill that nearly doubled line clearance tree trimmer's wages. Organizing Stewards, in a dramatic show of strength, were instrumental in lobbying for the adoption of this legislation.

Organizing — Organizing Stewards support organizing drives, both internal and external. Thompson stressed that Organizing Stewards are among the best evangelists for non-union members. Recently, at the City of Vallejo, where union density had dipped to nearly 50% due to dissatisfaction with contract gains in the aftermath of bankruptcy, the Organizing Team worked with the IBEW 1245's Business Rep, Kim Camatti, and built a strategy to increase union density a year before going to the negotiating table.

"We formed and trained a VOC to hold one-on-one conversations. Union density increased from 50% to nearly 90%. When we got to negotiations, we mobilized the strength of the Union: mobilizing members at the City of Vallejo and Organizing Stewards from other properties. With support from labor, political and religious allies, and the community, we packed City Hall meetings, and won a landmark MOU," said Senior Assistant Business Manager Al Fortier.

"It sounds like the internal organizing moved the needle at the negotiating table," said Michael Schreck, an Organizer from Local 191 in Everett, Washington. "Absolutely," said Fortier.

Fortier offered another example of the impact of Organizing Stewards. "Two years ago, a California Senate Bill (SB 284) sought to take away work from a vast swath of IBEW's membership in California. Under Business Manager Bob Dean's leadership, Organizing Stewards led a union-wide phone bank to mobilize targeted calls to legislators supporting the bill and successfully crushed it," said Fortier. Members who had never participated before got involved.

And a spark was lit.

Solidarity — Solidarity is the heart of the labor movement. Dispatching Organizing Stewards to support other locals and affiliates during their fights, not only provides an opportunity to exercise leadership, but also provides opportunities to learn and upgrade skills that stewards can then reinvest in their home local. Solidarity builds relationships that strengthen the entire labor movement.

Local 47 Organizer Andrew McKercher shared the experience of IBEW 1245 Organizing Stewards helping his local organize a contact center on the second round.

Cruz Martinez noted that multiple IBEW Locals from the 9th District and

State Federation affiliates stood with Siemens workers seeking to join our union. "The solidarity we received at the Siemens Campaign — over 155 volunteers — was something I'd never seen before," he added.

Solidarity campaigns created a repository of goodwill that translated into support for IBEW 1245's own fights.

Training — IBEW 1245 holds three trainings per year for Organizing Stewards, typically on their own time, to reinforce the hands-on training. Stewards learn about the history of IBEW, our local, the labor movement and current events. They meet elected officials, national leaders, their local union leadership, and subject matter experts, then report back to their co-workers.

Organizing Stewards participate in Central Labor Councils as delegates, and attend conferences where they see the bigger picture. They establish regional Organizing Steward gatherings to convene and meet co-workers as part of a "relational organizing" approach.

Leadership Development and Membership Engagement

The Organizing Steward program generates multiple opportunities to engage members at the worksite, at home, at Unit meetings, and in special mobilizations. Each conversation, campaign or fight becomes a training ground to hone leadership skills. Staff organizer Melissa Echevarria invited three Organizing Steward Leads — Danielle Bonds, Brenda Balcazar, and Kaeyla Jones — to share their leadership trajectories as Organizing Stewards.

Tracking Success

Finally, Cruz Martinez shared the tracking mechanisms, the lists, and the ways we measure success. To date, more than four hundred members have participated in the program. Nineteen Organizing Stewards have been appointed to the Staff. Countless others have been involved in Union committees, Central Labor Councils, and more.

At the end of every year, Staff meets with Organizing Stewards to evaluate the program and their role. Some eagerly ask to renew the appointment. A few opt out due to a host of reasons.

Fortier ended the day, thanking the brothers and sisters for their participa-

"We really appreciate your time today and look forward to seeing you tomorrow when you will see our Organizing Stewards in action. This organizing program is continuing to grow. We have changed from a union that only serviced contracts to one that engages our membership so that they understand everything we are doing and why!" he said.

The day was capped by a reception at the Hall, celebrating the Brotherhood and Sisterhood and the work. The next day, the forty guests joined ninety IBEW 1245 Organizing Stewards for a full day celebrating victories, identifying challenges, and renewing the commitment to the struggle for working families.

DAY 2 — IBEW 9th District Annual Organizing Training



Solidarity is not just a word we use. It is an action we take every single day!

Vacaville, CA — On a gorgeous Saturday morning, ninety IBEW 1245 organizing stewards gathered at the IBEW 1245 Union Hall to meet forty sisters and brothers from twenty-two Locals from across the IBEW's 9th District to demonstrate the IBEW 1245 Organizing program at work!

"Thank you for coming to the 9th district," declared IBEW 1245 Business Manager Bob Dean. "What you see here, is one hundred people who donated their time to help their brothers and sisters," referring to the stewards who volunteered their time to join their counterparts from across the 9th District for the training.

Sharing his story, Dean said, "I was up in Alaska in construction and utili-

born and raised by the law of the Union. My father was 1245. My mother was a communication worker. I've been here for 35 years, on staff for 20.

We are the biggest local in the IBEW. We are the second biggest construction union of any union in the nation. But none of that means anything without the men and women who stand up. When we go to Sacramento, they listen to me because we have 28,000 members behind us. When we go to the negotiating table, they know we are strong."

He emphasized, "Our tent is big, but it only works if we are strong and united."

Dean gave a special shout out to International Vice President Dave Reaves. Reaves, a 31-year organizer, journeyman lineman and proud third-generation member of IBEW 1547 came up in Alaska in construction and utili-

ties. Reaves currently heads up the IBEW 9th District, supporting IBEW Locals across California, Nevada, Oregon, Washington, N. Idaho, Alaska, and Hawaii. It was his idea to hold the annual 9th District Organizing Training at IBEW 1245 to learn about 1245's Organizing Program that has gained national recognition.

Brother Reaves thanked Bob Dean and 1245. "Thank you for allowing the 9th District to come into your training and for rolling out the red carpet," he said, adding, "Thank you for everything you do. Bob and Rene [Cruz Martinez] have been pretty modest. Any time I pick up the phone and ask, 1245 is there, financially, workforce, and beyond."

Reaves referenced the hard-fought Siemens campaign in which workers suffered a defeat, noting, "Siemens was continued on next page



round one. During the campaign, Siemens broke the International Framework Agreement we had." But they did not break our spirit.

He ticked off campaigns around the country to which 1245 has dispatched teams of Organizing Stewards, including Baltimore Gas & Electric, Electrolux, and Alaska.

He noted that when IBEW 1245 needed help to defeat Q3 — legislation that threatened 1245's Nevada members — Locals across the country reciprocated, sending in troops to successfully defeat the anti-union bill and protect

members and the community.

1245 Business Manager Dean next welcomed Leroy Chincio. Brother Chincio is the Business Manager/Financial Secretary for IBEW Local 1260 in Hawaii, and a member of the IBEW International Executive Council. He shepherded his local through the devastating fires that ravaged Lahaina, Hawaii in August of 2023.

"It's great to be here!" declared Chincio. "Make no mistake, I'm here to steal ideas. In Hawaii, we had Lahaina burn down. Bob [Dean] reached out to us and shared, 'This is what you do in a fire.' We were worried about our guys and putting out the fire. Bob gave us the roadmap. That's the kind of help we got from 1245. ... My proudest moment was when we got unsolicited donations from the IBEW without even asking. We had 12 members who lost homes... restoration is ongoing. It's going to be a long road."

The one hundred thirty organizers in the room engaged each other, shared campaign victories and challenges, and the methodology of building an organizing program, one conversation, one story, one campaign, win or lose, at a

the Chief of Staff at the Sacramento Central Labor Council hailed IBEW 1245 for the years of campaign work and leadership development.

"Solidarity is not just a word we use. It's an action we take every single day," stressed Volcy.

He added, "This program allows you to be strong in your union and in your community, because your community is going to need you more than ever. ... I don't know if you've been paying attention to the news ... We now live in a new world. And in this new world, the only thing that matters is how strong you are as a Union. They are coming for you. They are coming for the Union. They're coming for your ability to organize. They're coming for your ability to feed your family. They are coming for your ability to take care of yourself."

Organizer Charlotte Stevens led the room in a call to action — "List five names, co-workers, you will reach out to

and invite to get involved."

Assistant Business Manager Rene Cruz Martinez reinforced the message, saying it's never been more important to participate and to build relationships grounded in the brotherhood and in solidarity. "As Bob Dean said this morning, if you remember one thing, remember we must come together and vote, participate and fight."

Stewards broke into regional groups to map out activities to engage their coworkers and build participation, made more important than ever given that the Local has twenty sets of upcoming negotiations this year, including at IBEW 1245's two largest signatory employers.

Senior Assistant Business Manager Al Fortier closed the session thanking the Stewards and our brothers and sisters from the 9th District.

California State Association of Electrical Workers (CSAEW) Conference 2025: **A Call for Legislative Action**

Sacramento — This year's California State Association of Electrical Workers (CSAEW) Conference provided an important platform for advocacy and education on critical issues affecting IBEW members and the communities they serve.

More than a hundred delegates gathered in Sacramento to discuss key legislative priorities and engage in direct lobbying efforts.

Business Manager Bob Dean led IBEW Local 1245's delegation which included Senior Assistant Business Managers Al Fortier and Ralph Armstrong, Assistant Business Manager Hunter Stern, Staff Organizers Melissa Echeverria and Charlotte Stevens, and Organizing Steward Lead Alvin Dayoan.

Former labor leader and Assemblymember Liz Ortega kicked off the conference with a passionate speech, emphasizing the importance of organized labor in shaping policy. Her words resonated deeply with the crowd, fueling their drive to advocate for legislation that strengthens protections for workers.

Senate President Pro Temp Mike McGuire, Senator Dave Cortese, and Assemblymember Chris Rogers, also spoke. These influential political leaders reaffirmed their commitment to labor and pledged to continue supporting IBEW's legislative goals.

On the second day, Lobbyist Scott Wetch delivered a detailed briefing on the current slate of legislative bills, breaking down their potential impact on IBEW members before delegates began door knocking and meeting with Senators and Assemblymembers to push for support (or opposition) on key bills that affect IBEW members.

The legislative priorities presented by the CSAEW included permit streamlining, securing the viability of wildfire funds, enhancing penalties for assault or battery committed against public utility employees, and the pressing need for Net Energy Metering (NEM) reform to alleviate cost burdens on non-solar customers.

"Our lobbying efforts really made a difference in the future of labor. We're not just fighting for our members, we're fighting for fairness for all Californians," said Dayoan. "These bills are about creating a safer, more equitable environment for working people across the state."

Ninth District International Vice President Dave Reaves, capped the conference at the final plenary, emphasizing IBEW's unwavering commitment to upholding worker rights. Reaves' address was a powerful reminder of the collective strength of the IBEW and the ongoing efforts to ensure a secure future for working families.

As the conference concluded, the collective resolve of the CSAEW delegation was clear. With their legislative priorities in motion and a renewed sense of solidarity, IBEW members left Sacramento with a clear mission: to continue fighting for a better, safer future for the workers of the IBEW, their families, and the communities they serve.

IBEW 1245 Fight for Utility Worker Safety Bill — SB 431

At the Senate Public Safety Committee

Sacramento — IBEW 1245 Organizing Stewards joined Staff to testify in favor of 1245's-sponsored Utility Worker Safety bill before the California Senate's Public Safety Committee.

IBEW 1245 Political Director Hunter Stern served as the lead for IBEW locals, while SDG&E has been leading the Investor-Owned Utilities on the bill. Like PG&E, their workers have experienced several very serious assaults, one of whom shared their testimony.

The bill — authored by newly elected Senator Jesse Arreguin, the former mayor of Berkeley — passed unanimously out of the Senate Public Safety Committee by a 6-0 vote.

Next Steps: The bill now goes to Appropriations before hitting the Senate floor.

Siemens Workers United Lose Hard Fought Election, Pledge to Keep Fighting

Sacramento – IBEW 1245 made significant inroads towards organizing Siemens Mobility in Sacramento despite coming up short in a union election on March 13, 2025.

Sixteen hundred workers in a production unit consisting of assemblers, equipment operators, painters, material handlers, maintenance technicians, and welders fought valiantly, even as they faced a brutal anti-union campaign waged by Siemens Mobility management.

Siemens Mobility is a division of Siemens AG, a global technology company focused on industry, infrastructure, transport, and healthcare, headquartered in Germany. The Siemens

Mobility's manufacturing facility in South Sacramento is a major fabrication site for the company's locomotive, coach, light rail, and high-speed train products.

Local 1245 and the International Brotherhood of Boilermakers Local 549 (IBB) joined forces to lead the organizing drive, calling the initiative, "Siemen's Worker United." The Union and Company adopted an "International Framework Agreement," defining rules of engagement. A Volunteer Organizing Committee (VOC) was formed and worked diligently to reach out to co-workers and build support for the unionizing drive over an eighteenmonth period.

Substandard wages, serious safety concerns, and inadequate training were among the issues propelling workers to organize.

IBEW 1245 Assistant Business Manager Rene Cruz Martinez stated, "The VOC and Union organizers mounted an impressive, comprehensive campaign. We did the research, held weekly meetings and trained VOC members to hold countless one-on-one conversations. Once we filed authorization cards, we went into high gear, mobilizing one hundred fifty-five volunteers to door knock, phone bank, and leaflet in between every shift."

"Our staff worked around the clock. We mobilized Organizing Stewards. IBEW International Vice President for the 9th District, Dave Reaves, joined us on the line. Organizers from other IBEW locals in the IBEW's 9th District along

with affiliates from the California Federation of Labor and the Sacramento and NVLF labor councils dedicated days to stand with us. State and Local elected leaders joined workers on the line! We worked in English, Vietnamese, Dari, Spanish, Hmong, Russian, Ukranian and Tagalog to meet the workers in the language in which they were most comfortable," Cruz Martinez added.

Though tremendous gains were made educating the work force and signing up members,

high turnover rates and a classic antiunion campaign worked against the prounion side. The Union was also handicapped by not having access to workers inside the plant, and the violation of the International Framework Agreement by the company.

In the end, fear and intimidation won the day.

IBEW 1245 Business Manager Bob Dean, stated, "Out of 1,444 ballots cast, 833 voted no; 538 voted yes. No loss is easy, and this one is no exception. The company conducted a vicious anti-union campaign and broke many of the rules up to and including on election day."

He added, "I want to thank everyone for their hard work. I especially want to single out 1245's Assistant Business Manager Rene Cruz Martinez, Organizer Rick Thompson and the entire

organizing team and organizing stewards who worked tirelessly on this campaign. They left no stone unturned. They came up against a myriad challenges and never gave up. They recruited and mobilized allies from many sister locals, from Central Labor Councils, from the CA Labor Federation and local and state politicians, making us all proud. Lessons have been learned, seeds have been planted. We are stronger as we face the next fight."

On Thursday, March 20th, IBEW 1245 and Boilermakers 549 filed a joint objection to the company's actions during the election, listing sixteen allegations of misconduct.

Senior Assistant Business Manager Al Fortier declared, "Despite the results of the election, I am extremely proud of the effort of our organizing team. We fought hard, demonstrated unwavering commitment to this campaign, and put our energy and expertise on full display. Our friends and allies answered the call. We owe a great deal of gratitude to so many people. I cannot thank them all, but I would like to thank our Business Man ager, Bob Dean, and our Executive Board for their unwavering support, our organizing team and organizing stewards, and our administrative and field staff. We will continue to set the standard for IBEW and the labor movement. and we will continue to FIGHT until we WIN."

IBEW 1245 Launches Union Training for PG&E Traffic Control Workers

Vacaville — Since its formal creation in 2020, PG&E's Traffic Control department has experienced remarkable growth.

What began as a shift to move work in-house, expanding from approximately 50 employees to 200, has now surged to nearly 450 good union-represented career jobs. This rapid expansion, in partnership with PG&E, has provided a critical entry point into the utility industry, where such opportunities have become increasingly rare.

Unlike many other departments within PG&E that have long-standing traditions and established cultures, the majority of Traffic Control members are relatively new, with less than two to three years at the company.

With this in mind, these relatively new IBEW 1245 members expressed a strong interest to learn more about the Union and how to get involved. To meet this demand, IBEW 1245 recently hosted its first-ever union training for Traffic Control members. Thirty-five participants from across PG&E's service territory participated. The training covered a wide range of topics, including the history and structure of IBEW and IBEW 1245 and leadership opportunities such as steward roles, unit meetings, and committees. We dove into a discussion about the union difference. We reviewed the gains made for Traffic Control/Flagging workers and upcoming PG&E negotiations. Political Director Hunter Stern presented on the importance of politics and their impact on work.

The response of our members was overwhelmingly positive.

Nikki Eddy, a Traffic Control Utility

Worker from the Hayward Yard, expressed gratitude for the opportunity to learn from those who paved the way, stating, "I'm really excited to be a part of such a strong Union. The training was very informative, and it's great to learn from those who came before us and led the way. Their hard-won experience has opened doors for the rest of us, and for that, I am grateful."

Jermaine Eti, a Traffic Control Flagger from the Sacramento Yard, described the training as an eye-opening experience, reinforcing the importance of strong representation, workplace safety, and the power of solidarity, declaring, "The training provided valuable insight into how the union fights for workers' rights, ensuring fair wages, benefits, and job security. ... The energy in the room, the shared sense of purpose, and the experienced leaders passing down knowledge made it clear that being a part of the Union is more than just a job-it's about protecting the future of our workforce. I walked away with a deeper appreciation for the work our Union does and a stronger commitment to contributing to that mission. If you

ever get the chance to attend, I highly recommend it. It's a great experience that equips you with the knowledge and confidence to make a real impact."

For me, it was refreshing to see so many new members energized and eager to learn more about their Union, to get involved, and deepen their understanding of the union difference. I'm excited to see how this group continues to grow, develop, and become future leaders of our union.

With this successful first training in the books, IBEW 1245 looks forward to continuing to educate and empower Traffic Control members. More trainings will be scheduled in the future to ensure all members have the opportunity to strengthen their union knowledge and leadership skills. As the department continues to grow, so too will the commitment to fostering a strong, engaged, and well-informed workforce.

WESTERN LAMPAC Tackles Challenges Facing Industry

BEW 1245 leadership participated in the Western LAMPAC (Labor and Management Public Affairs Committee) Conference in San Diego, California this Spring.

Founded more than fifty years ago, Western LAMPAC is an association of Electric Utilities, signatory contractors and IBEW Locals from across the 7th, 8th and 9th IBEW Districts, covering seventeen western states. It includes not only IBEW locals, but many of our major employers, including PG&E, NV Energy, San Diego Gas & Electric, and So CA Edison.

Meeting twice a year, attendees discuss trends, issues, and the everchanging landscape of the utility business. Over recent years, wildfire dangers and mitigation, electrification, and the urgent need to address the grid have been constant topics. In addition to informing and educating its members on public affairs matters and exploring strategies to influence legislation, it provides an opportunity to "promote positive labor management relations through cooperative efforts."

IBEW 1245 Peer-to-Peer Safety Committees Stand Out at NV Energy Safety Kick Off

Spreading the Word About Safety

RENO — On January 28, 2025, representatives from IBEW 1245's Peer-to-Peer Safety Groups attended the annual NV Energy Safety Summit. More than five hundred attendees participated in the event at the Atlantis Casino & Resort in Reno, Nevada.

As they entered the venue, participants visited tables manned by 1245 leaders of the Regulate the Voltage (RTV) peer group, Hold the Pull (HTP) peer group, and Control the Pressure (CTP) peer group.

Safety Committee representatives talked with employees about the Union's commitment to building a safety culture on the ground and answered a myriad of questions. They distributed flyers and union stickers and recruited two employees who expressed interest in joining the RTV peer group.

Representing IBEW 1245's safety committees were RTV peer group members Neil Norris and Mike Tafoya; HTP peer group members Pete Sandoval, and Jesse Morelos; and CTP peer group members Ernie Peña and Kevin Foster. They were joined by IBEW 1245 Business Representative Fred Aboud who coordinates the peer-to-peer safety program.

During the conference, IBEW 1245 Business Representative Adam Weber presented numerous awards in recognition of continuous safety streaks—some as high as 30+years—during which time there were no OSHA recordables.

Brother Weber also dove into the history of the IBEW, emphasizing that the

union was founded on safety at a time when one out of two linemen died on the job.

"Nothing is more important than working safely and going home to our loved ones at the end of the day," declared Aboud, coordinator of the peer-to-peer safety program.

Peer-to-peer safety leaders Neil Norris, Ernie Peña and Jesse Morelos addressed the conference, sharing the work of their respective safety committees and how to get involved. On the side, Committee members networked with each other, sharing ideas about how to encourage people to get involved to advance safety at the workplace.

Getting to represent the safety peer groups in front of a crowd of over five hundred was an enormous opportunity to spread the word about safety.

Overall, the trip was a huge success.

A true example of being your brother's keeper

Sunnydale, San Francisco — On Wednesday, February 12, 2025, our IBEW 1245 GC gas crew was involved in a serious safety incident, challenging our members beyond their wildest imaginations.

It started like any normal working day for the GC gas crew headquartered out of the PG&E Potrero substation in San Francisco.

The crew's job for the day was to replace and re-run underground gas lines in the Sunnydale neighborhood. The neighborhood was known to be a tough area. On many occasions, crews have been accompanied by a police escort while working in the area.

Unfortunately, on this particular day, a police escort was not available to accompany the crew as they worked.

Around 1pm that day, while IBEW 1245 members were working at the jobsite, two separate third parties opened fire on each other from vehicles. In the blink of an eye, the gas crew was caught in the crossfire. Members took cover wherever they could while bullets flew. More than 40 gunshots were fired.

"It was a scary situation, when the shots rang out. I just reacted by getting out of my backhoe and jumping from it into the trench I was digging below for

cover," said Backhoe Operator Jeff Gallagher.

"We yelled out for everyone to get down. It was a crazy situation," added Gas Street Fitter Roger Nguyen.

Regrettably, one of PG&E's traffic control flagging contractors suffered a gunshot wound to the lower leg. One of IBEW 1245 members, Toamalama "Lama" Tufono was next to the flagger who was shot.

"We were in the direct crossfire of the shooting. I got down when the gunshots started. I could see that he was shot, and my thoughts were flying in my head. I didn't know if I should just stay down because they were still shooting. But something in me told me I had to try to do something, or I could not live with myself, so I just reacted," said Gas Utility Worker Toamalama Tufono.

Brother Tufono, who has only been working at PG&E for four months, got up

and dragged the injured PG&E contractor to safety behind a car while the shooting continued. When both third party vehicles stopped shooting and left the jobsite, EMS and police arrived on scene, and treated the traffic control flagger who was shot. The injured contractor was taken to the hospital, was treated for the gunshot wound and released.

The next day after the shooting, IBEW 1245 Safety Director Jody Castro and I met with the workgroup in San Francisco, to listen, show support and help the crew process what had happened.

Drawing on the experience of police and fire who have developed peer support programs for co-workers following traumatic safety incidents, IBEW 1245 is developing a "Critical Incident Stress Management" (CISM) to support our members following serious traumatic events like the one our GC Gas Crew crew experienced. The program provides training and therapeutic support for members directly involved, their coworkers and families.

Thanks to quick action of everyone on the crew, especially brother Tufono who risked his life for another, the incident on Sunnydale Street did not end with anyone losing their life.

The entire IBEW Local 1245 is proud and grateful for our members' actions that day.

It is a true example of being your brother's keeper. It is not easy to show up every day in San Francisco and perform gas and electrical work for the public, and no one expects to be involved in such a scary incident like our crew just went through. I am deeply proud to represent the IBEW 1245 members in San Francisco who service their community."

1245 Member Freddie Hewitt, II and the CTP Committee: *Profiles in Courage*

"I want to help others avoid what happened to me."

wo and a half years ago, IBEW 1245 member, Freddie Hewitt, II, a PG&E Gas Compliance Representative (GCR) from San Carlos, California defied the odds and lived.

Less than one and a half months into his new job at PG&E, Brother Hewitt was attacked at work by a random, knife wielding passer-by on the street who stabbed him in the neck, hitting his jugular.

According to Hewitt, thanks to quick action from his crew, the police, and medical team, he survived the attack. It was no small task, requiring a six-hour surgery and a long, painful recuperation.

Today, after two years of recovery and hard work, Brother Hewitt is back on the job. "I'm doing much better, though I've lost function in some of my limbs and have permanent facial nerve damage; I have to take care when I'm eating," he shared. He also deals with the emotional scars of the assault and the stress that goes along with facing his assailant in a court of law. Court proceedings are in process as of this writing.

But his spirit is indomitable, according to IBEW 1245's GSR Ernie Peña.

Peña, himself, an IBEW 1245 GSR who survived a shooting while at work, reached out to Hewitt, sharing, "I just wanted to support him. I've gone

through the same thing," said Peña. "The first emotion is fear that this could happen again, then anger, because the company isn't providing adequate support, and then action."

For Peña, action translated into becoming Chairperson of the IBEW 1245's peer-to-peer Control the Pressure (CTP) safety group.

The CTP peer-to-peer program is dedicated to educating the membership about the importance of safety on the job. The motto is, "If you see something, say something." It is one of IBEW 1245's four peer-to-peer safety Committees.

Led by Peña, IBEW 1245's CTP program successfully pressured PG&E to adopt enhanced communication systems to alert all PG&E employees if there's been an assault or other hazards in real time and to provide dedicated armed security for crews working night shifts and day shifts as needed. They played a key role developing a working relationship with the Oakland Police Department. Peña also set up a monthly meeting for survivors to meet and check in with one another. "It heals you when you talk about it. PTSD is real," he said.

Peña recruited Hewitt to join CTP, and enlisted him to share his story at trainings, safety summits and yards.

In late January, 2025, Brother Hewitt told his story at the PG&E Leak Survey/Corrosion Safety Summit, the first in a series. Joining members of the CTP Advisory Committee, he emphasized the importance of situational awareness.

"Brother Hewitt is selfless in his sharing of his story on what occurred when he was violently attacked and suffered a life-threatening injury. But, instead of 'why me' he has chosen to take this experience and use it as a tool to provide a teachable moment for his brothers and sisters in situational awareness and that hazards can come in an unconventional manner," stated IBEW 1245 Business Representative Kadota who was hearing Hewitt's story for the first time.

Kadota added, "In the short time that I listened to him, he set the example to me of what it truly means to be a Brother's Keeper. To not only overcome a potential negative life changing event and use it as a tool to reach out and help others become safer not just on the job but, in life, is true admirable."

IBEW 1245 Safety Director Jody Castro stated, "It is incredibly courageous for Freddie to go back to work in the field where he was assaulted. Hopefully, by sharing his story he will help prevent others from suffering the same."

CTP Advisory Council member Nilda Garcia, a Traffic Control Utility Worker stated, "Freddie's story had me in tears." She praised the work of the CTP peer-topeer group saying, "CTP is instrumental in our day-to-day work life. We promote safety in every aspect of our work...making sure our brothers and sisters work safely so they go home to their families

at the end of their shifts."

Meanwhile, IBEW 1245 is exploring the development of a "Critical Incident Stress Management" initiative modeled on programs fire and police departments use to support their employees. The program provides training and therapeutic support for members, their co-workers and families following a traumatic event such as the one Hewitt suffered.

Brother Hewitt shared, "I want to help others avoid what happened to me, and if something happens, I want all the pieces to be in place to help."

He went on to thank his family, his co-workers, the police, corporate security, the medical team, and the union for their unflinching support. "Thank you for all the support; you helped me through the dark times; thank you for worrying about each other," he said.

SETTING A HIGH SAFETY BAR 1245 Members at GC Bakersfield Set the Example

Bakersfield — In late March, 2025, IBEW 1245 Members out of the Bakersfield GC Line Department (PG&E), were celebrated for going 3,602 days without a lost time accident.

The extraordinary feat was recognized by PG&E Management after IBEW 1245 Senior Assistant Business Manager Bob Gerstle brought it to their attention.

Gerstle said, "On a recent yard visit

with Bako GC I noticed a signboard that showed a very large number of days worked without a safety related incident. I was positive it was a mistake and decided to reach out to PGE leadership. They were not aware of this amazing performance and agreed these members deserved special recognition."

At a time when the industry is searching for ways to build a safety culture and

reduce serious injuries or fatalities, the crew's safety record is a source of pride. Long time members, Subforemen A

Blair Zimmerman and Gavin Salcido, captured the ethos of the group saying, "Safety is at its best when rooted in a positive culture. The foundations of a positive safety culture are made through clear rolls, responsibilities, and a mutual understanding of expectations. These foundations can be fortified by the understanding that as you progress through your career and acquire new roles, the expectation is you are still responsible for what you already bring to the work group as well as your new responsibilities. This helps create a space for coaching and mentoring to pass down a legacy. When you pass down a legacy it makes the work and the people personal to you. When it's personal you take care of your tools, you

take care of your equipment, and if you can take care of those things, you can take care of the Brother working next to you. Be your Brother's keeper."

IBEW 1245 Business Representative Mark Rolow, declared, "These men have pride in the work they do and how they do it. It shows by their safety record. I am honored to call them brothers."

IBEW 1245 Business Manager Bob Dean who served as the Union's Business Representative in Bakersfield from 2006–2011 before joining the Administrative Staff stated, "The linemen in Bakersfield have always been an example of what we can do if we work together."

Congratulations to the entire crew for setting a high bar when it comes to safety. You are an inspiration to us all.

PG&E Electric Work and Resource Dispatchers:

Keeping Us Safe and the Power Flowing

"Like Riding a Roller Coaster as they Juggle a Dozen Eggs"

On any given day, PG&E telephone lines are buzzing with customers' calls from across its vast territory.

Serving nearly 16 million Californians from Bakersfield to Eureka, incoming calls include requests for services, help with customer billing, and sometimes, reports of downed wires, outages, or other emergencies.

Enter Electric Work and Resource dispatchers, who play an indispensable role keeping the power flowing and keeping communities and crews safe.

These IBEW 1245 members monitor, analyze and assess situations (both emergencies and non-emergencies), dispatch crews and resources in real time, and maintain clear lines of communication with first responders, crews and customers.

Origins

The Electric Dispatch Department was established in 2012 as part of the response to the deadly explosion in San Bruno, CA two years prior. The inaugural cohort consisted of twenty dispatchers, thirteen of whom hailed from the gas side of PG&E. The seven others were Assistant System Operators (ASO). Today, there are thirty-nine Electric Work and Resource Dispatchers. Nick

Allgood, a 26-year IBEW 1245 member and Dispatcher, described the work, saying, "Our primary purpose is to ensure the safety of customers and crews as they perform emergency and non-emergency work by effectively and efficiently dispatching electric emergency work as well as non-emergency work."

Emergency and Non-Emergency Work of Dispatchers

Emergency electric work includes downed wires, broken poles, trees on lines, structure fires, electrical dig-ins, and other electrical hazards that pose a threat to life or property. Allgood's focus is on dispatching personnel when 911 emergency personnel are on site or en route to a hazard. He dispatches crews during EPSS outages and Gridware notifications.

He also handles numerous calls from Contact Center personnel, advising of immediate response field orders or requesting an override for a same day non-emergency customer field visit, typically a disconnect or reconnect of service.

In emergencies, Dispatchers coordinate with 911 and route T-men to mitigate hazards quickly. They are responsible for guaranteeing clear, quick communication during EPSS outages based on CPUC and company requirements and engage with field crews on location at all times to ensure they are safe while on jobs through hourly check-ins.

Non-emergency electric work such as installing electric service, disconnecting/reconnecting service, streetlights, inspections (capacitors, regulators, SCADA) and other work that does not pose an immediate hazard to life or property is also part of Electric Dispatchers core responsibilities.

The job is nonstop and requires a comprehensive working knowledge of PG&E systems, work groups, and fluency with computer programs and apps, and requires intensive training.

Dispatch Training

New Dispatchers enter the department as Dispatchers-in-Training (DITs). As DITs, they must successfully complete a strenuous 6-month training that constantly challenges their ability to remain cool, calm and composed.

Upon completion of the training, they are required to pass a proficiency assessment in order to become a qualified W&R Dispatcher. This intense training provides an in-depth understanding of the Electric Distribution system with an emphasis on Human Performance Tools to communicate effectively with all customers, 911 and public agencies. A portion of the training is dedicated to conducting a thorough analysis of Dispatch and Mapping applications to safely and accurately monitor the fleet. Dispatchers master the geographical diversities of the service territory to identify potential impacts to response and travel time and provide an accurate Estimated Time of Arrival (ETA) to 911 agencies.

Safety: the Number 1 Priority

"Ensuring the safety of customers and field partners is my number one priority!" Dispatcher Tommy Keys.

"I prioritize all work that poses a threat to life or property and make sure I get a resource as quickly as possible to the hazard," said Keys.

Just as important as safeguarding the safety of customers and crews is keeping the electricity flowing.

"The customer is the reason I have my job, and I make every effort to keep their lights on," said Allgood.

Both Allgood and Keys stressed the importance of clear and timely communication with field partners, first responders, and customers for emergency and non-emergency situations.

IBEW 1245 Business Representative Eddie Moreno summed up the character of Electric Dispatchers, saying, "Electric Dispatchers possess an unmatched tenacity and dedication for providing safe and reliable service. Their commitment to ensuring the safety of our brothers and sisters in the field is inspiring. This group truly embodies the meaning of brotherhood. Having worked in a fastpaced, high-stress environment myself, I admire their persistent effort and perseverance when they are faced with challenges caused by procedural discrepancies, mismanagement of resources or the constant badgering of calls coming in. It's like watching someone ride a rollercoaster as they juggle a dozen eggs while trying not to break one."

Groups are nominated by a majority vote at local Unit meetings. They receive funds once the requests are reviewed and approved by the IBEW 1245 Executive Board.

GERALDINE BRADLEY — A Bad Ass Journeyman Lineman Gets Ready to Retire

Emeryville, CA — Growing up in Monterey, with a parent stationed at Fort Ord, Geraldine Bradley never had dreams of college. She was hoping to get on with the Forest Service, but as a backup she enrolled in a local welding class that was designed to help veterans find a job when their service time was up.

One day, she spotted a flyer on a bulletin board that talked about an opportunity at PG&E. There was a new program to change regulators at gas meters, and the chance to start an actual career outweighed the uncertainty of what welding would bring. Geraldine got a letter of recommendation from her instructor and applied to PG&E.

A few months later, the call came. The position was with GC Gas replacing K regs. It was a foot in the door to what would become a long career with PG&E. She appreciated the chance to have a

union to represent her, having been subjected to incidents with past employers where sexual harassment and favoritism had become problematic.

While working with GC Gas in Monterey, a nineteen-year-old Geraldine migrated towards a work group that at the time she called "the cool kids." That was the electric line crews, and she asked questions about getting into that trade. Soon thereafter she got a bid as a groundman in Monterey.

It was sometime in the mid-90s where our paths first crossed at a basic climbing class in Kettleman, CA (yes kids, there was a training school for PG&E apprentice linemen before Livermore.). Our paths have crossed a lot since then, and we've remained friends over the years.

Geraldine left PG&E as a 5th step apprentice in 1989, moving up to Helms

Power Plant where her then husband worked and lived as a PG&E comm tech. She missed her apprentice job, and got hired back by Fresno GC as a 3rd step. When the IBEW 1245 rep heard about this, he fought to get Geraldine reinstated as a 5th step apprentice, being that she was gone less than 12 months. She topped out as a journeyman in 1991.

One point Geraldine made over and over in our conversation was, "I'm a lineman—don't you dare call me a line worker. I worked my tail off my whole career to be just that, a lineman. Not a female lineman, I'm a lineman who happens to be a female."

We don't have the time to list every yard Geraldine has worked in since topping out. She was absolutely the first female Troubleman at PG&E (sorry Geraldine). If you've been around, you've likely at least seen Geraldine during a storm, if not headquartered in the yard you work in. First as a Troubleman (no Troubleshooter for her), then over recent years as a Distribution Line Technician (DLT), this woman has been all over the PG&E system.

Geraldine is currently in East Bay as a DLT, working toward the 24-month requirement to make her Bay Area premium pensionable. She helps out as an instructor with new DLTs and the everchanging technologies that are introduced to the grid.

As we wrapped up our lively discussion, she looked back on the Covid years. She was appreciative that IBEW1245 fought for member's rights to decide on whether they wanted to get a vaccine shot. "If my ability to make my own decision had been taken away, I was prepared to leave the company." It would have been a loss if she had been forced to make that decision.

Geraldine will retire later in 2025. She's purchased a home in Florida, and is looking forward to taking up golf and playing more pickleball. I sense it won't be an easy transition for a person who's been a dedicated employee and 1245 member for over 35 years. We wish you the best Friend, you've earned this ride.

Her journey with the company has been one of resilience, adaptability, and unwavering commitment, leaving a lasting impact on her colleagues and the organization as a whole.

Pauline began her career with PG&E on February 7, 1985, as a Meter Reader. When an injury prevented her from continuing in that role, she faced a crossroads that would ultimately define her career. Willing to embrace change, she moved from Santa Maria to Oroville in 1997, taking on a new position as a utility clerk. Though it was a significant move for her and her family, it turned out to be a positive transition.

In 2000, Pauline transferred to the Sacramento Call Center as a Service Representative, before bidding into the Auburn office in 2001 and later moving to Grass Valley, an ideal location for her after purchasing a home in Penn Valley. However, an unexpected opportunity in 2002 altered her path once more. She had unknowingly placed a bid for a position in the North Valley Materials Department as a Materials Handler and

was encouraged by a coworker to accept the role. That decision became one of the best she ever made, opening doors to invaluable experiences and skill development.

As a Materials Handler, Pauline mastered the operation of forklifts, trucks, and the intricate process of ensuring crews had essential materials, especially during storms when urgency was paramount. Her hard work and leadership skills led to her eventual promotion to Materials Lead, a position in which she thrived.

Pauline's leadership beyond operations and into safety, one of her greatest passions. She began leading safety meetings during her time as a Meter Reader and remained a steadfast advocate for safety throughout her career. She was a member of the Warehouse Safety Team until her final day and served on the Materials Safety Action Team multiple times. Often stepping up as a safety leader, Pauline used the knowledge she gained not just at work but in her personal life as well, and she remains grateful for the safety education she received.

Beyond her official duties, Pauline was a strong advocate for workplace unity and professional growth. Her involvement with our Union began early in her career when she attended her first Unit Meeting as a Meter Reader. Over

time, she took on the role of Unit Recorder, gaining insights into the bidding process and the diverse career opportunities available at PG&E. She encourages new employees to attend Unit Meetings, where they can find support, explore career paths, and have their voices heard.

Reflecting on her career, Pauline recognizes the vital role our Union played in securing the wages and benefits that now allow her to enjoy a well-earned and comfortable retirement. Though the retirement process itself was more challenging than expected, she offers valuable advice to future retirees: request the necessary paperwork at least four months in advance and anticipate delays in the process.

Pauline's legacy at PG&E is one of perseverance, leadership, and dedication. Her co-worker Bryce Melani shared, "I would simply say how much she will be missed and how she's leaving pretty large shoes to fill after putting so much time in at the warehouse. She always kept on task at work but every now and then she would have the wildest stories that would make everyone around her laugh hysterically."

Vanessa Ricci, another colleague, added, "Pauline's commitment and passion have always been inspiring and while we will miss her leadership, we are excited for the new chapter ahead.

Celebrating the Legacy of Cesar Chavez Day 2025 — April 4

Prom Delano to Sacramento to Reno, IBEW 1245 members participated in marches and celebratory dinners marking the life and legacy of civil rights and labor leader Cesar Chavez on what would have been his ninetyeighth birthday.

Chavez, the co-founder of the United Farmworkers Union, was instrumental in exposing the abysmal working conditions suffered by farmworkers and built a movement that led to major gains for farmworkers. One of the greatest accomplishments was the successful passage of the California Agricultural Labor Relations Act

(ALRA), enacted in 1975. The landmark legislation established the right to collective bargaining for farmworkers in California, a first in U.S. history. It was also a training ground for a generation of committed labor organizers, including former IBEW 1245 Business Manager Tom Dalzell and the late Fred Ross Jr.

Thousands gathered in Delano – long viewed as the cradle of the farmworker movement. A central theme of the day was the assault on unions and immigrants, especially immigrant workers.

IBEW 1245 member and Organizing Steward Lead Rodrigo Flores represented 1245 and the North Valley Labor Federation. Speaking to the crowd, Flores said, "I'm here today because I believe it's important to support immigrant workers. At the end of the day we are all workers trying to build better lives for our families. Right now immigrant workers are being unfairly criticized by our government. Hard-working, law-abiding families just like mine are simply trying to make a better

future. It's not right to bash the very people who are feeding our country and doing some of the hardest jobs out there," said Flores.

In Sacramento, Organizing Stewards led the 23rd annual Cesar Chavez march and manned a booth. They engaged young and old alike, sharing the mission of the Union and information about how to join, including our scholarship programs

Organizing Steward Lead Alvin Dayoan reported, "It was an incredible event, and we were delighted to see new members participating in our labor celebrations."

In Reno, Business Representative Marty Kumle was joined by active and retired 1245 members at a dinner sponsored by the Northern Nevada Central Labor Council.

More than 200 students — mostly juniors and seniors — filled the gym to learn about career opportunities as they imagine their next steps after high school. Most participate in the school's Career Technical Education (CTE) Pathway program which seeks to give students exposure to opportunities beyond the traditional college route.

especially girls and women.

IBEW Local 6 Celebrates International Women's History Month

San Francisco, CA – The IBEW 1245 Women's Committee broke bread with the brothers and sisters of IBEW Local 6 at their second annual Celebration of International Women's History month.

Close to one hundred fifty members gathered for the celebratory dinner which was held at Local 6's Union Hall in San Francisco.

IBEW Local 6 Business Manager John J. Doherty welcomed the crowd which included Local 6 members and guests from Local 1245, Local 617 and Local 302 as well as Dave Reaves, 2nd Vice President Ninth District of the IBEW and IBEW Interna-

tional Representative Marcie Obremski out of the 9th District.

Representatives of the Building Trades, three electrical Contractors, and Sisters with Tools, a free apprenticeship program sponsored by the San Francisco Building Trades, also participated.

Brother Reaves commended the women and men gathered and reiterated IBEW's commitment to increasing the number of women in the trades.

He noted that the number of women entering apprenticeship programs has risen by 90% since 2016, while acknowledging that the number of women in the trades remains 9.5%. "A percentage we will increase," said Reaves. How? By exposing girls and young women to the trades, tutoring them, mentoring them, organizing them, including them in promotional materials, recruiting them, and providing scholarships.

He encouraged brothers in the trade, saying, "Be mentors at the job site...be an ally, be an upstander, not a bystander, and ensure they are treated with dignity and respect."

Sister Obremski, a first-generation union member in her family, shared her story, saying, "It took me four attempts over four years to get into an apprenticeship program at MTA." She credited a shop steward — a mentor — who pressed her to keep trying. "They told me not to give up." On the 4th interview, "I told the committee 'I don't know what it's going to take to get in, but I'm coming back every year, even if it takes doing a cartwheel," she said. That was the year she was accepted. Today she serves on the International's Women's Committee and is the liaison with registered and informal Women's Committees across the 9th District.

"What kind of mentor do you want to be?" asked Obremski, inviting locals to participate in an emerging mentorship program, Small Connections that the International has piloted.

Her advice to young women considering the trades: "Never give up....keep going, keep shattering the glass ceiling, let them know you are in the room." She added, "You can't spell Brotherhood without her."

"You can't spell Brot(her)hood without 'Her'!"

Brother Doherty then recognized two outstanding sisters from Local 6 — Frances Rios, an inside electrical foreman and Ana Valdillez, the recently appointed Safety Officer for Local 6 to a rousing ovation.

IBEW Local 6 Assistant Business Manager Osha Ashworth closed the event saying, "Women are capable. Don't ever let your gender define you...Whatever you choose to do, put your best foot forward. I've been fortunate to work with many great mentors, many women and many men."

She called upon everyone in the room to teach our children. Show our "boys and girls they are capable, from building sandcastles to building skyscrapers."

State of the 9th District Report

IBEW District 9 International Vice President Dave Reaves commended IBEW 1245 for the successful Grid of the Future conference and the consistent leadership role 1245 has played building effective working partnerships with employers, growing the union, and

leading initiatives to meet rapid changes taking place in the energy space.

"We are in the middle of the second industrial revolution. New technologies, new energy sources, AI, data centers, robotics will require new skill sets across our fields."

The volume of work is on the rise. To keep pace with demand, he stressed the importance of recruitment and training the next generation of every classification. Case in point: 85,000 trained and qualified electricians per year over the next five years are needed in order to meet projected demand.

In anticipation of more manufacturing jobs, the International is standing up a New Clean Transportation and Electrical Training Trust that will work with all eleven IBEW districts. Reaves thanked Bob Dean and 1245 for the instrumental role IBEW 1245 has played conceptualizing and setting up the Trust.

Organizing is critical. As of late April, IBEW membership hit 856,000 members. Of those members, 157,299 are in the 9th District.

Bottom line: "We've got to embrace change. You are the future. We're the ones doing the jobs, getting the training, ...IBEW will lead the way. It's in our wheelhouse. It's an exciting time. I've never seen anything like it," said Reaves.

Business Manager Report

Bob Dean concurred. "The Grid of

Future conference was about change. Most of the change is an opportunity. As we move forward —no matter where you look—there is a generation of work coming. How do we staff it? How to survive the technological changes? We're doing everything we can to keep and defend our work."

PG&E's pilot program, PROPEL, a new version of SAP, aims to "modernize its technology infrastructure," and, if successful, could have a detrimental impact on our clerical members. The introduction of more AI could have an impact on many of our other members as well. We need to be prepared for all of it.

In 2025, no fewer than 20 sets of negotiations are taking place, including PG&E and SMUD, two of our largest employers. Dean thanked members who submitted more than 13,300 pro-

posals to the PG&E Bargaining Committee and 1,141 proposals to the SMUD Bargaining Committee.

In response to questions about the future of gas, Dean stated that gas is in a good position. "Every day, the system has grown. We also have hydrogen hubs, experimental plants in Lodi, and clean natural gas projects. Every gas plant lease has been extended. California cannot meet its electrification goals without gas. In northern Nevada we believe we will building new gas plants."

In addition to major negotiations, IBEW 1245 is in the middle of election season. Union officers, the Advisory Council, and delegates to the International Convention that will take place in San Diego in 2026 are on the ballot.

Reports

Advisory Council Members delivered reports. Many thanked the Local for hosting the Grid of the Future Conference as well as for making safety and mental health a priority. They shared concerns, including the impact of 1) recent Executive Orders terminating union contracts for some federal employees, including IBEW 1245 represented members at WAPA, 2) PG&E assessments of line clearance tree trimmers and 3) violence in the field.

The next Advisory Council meeting is Saturday, July 26, 2025.

Winters High School Students Test Their Skills

March 21, 2025 — Nearly twenty teams of high school students from across the region came together on March 21 to test their skills and determination at the Winters FFA Fabrication Contest, held at the PG&E Gas Safety Facility in Winters, California. This dynamic, hands-on competition gave students a rare opportunity to apply classroom learning in a real-world setting, reinforcing local schools' commitment to personalized education and career-readiness programs.

IBEW 1245 proudly participated in the event, with Member Kaycee King and Business Representatives Phuong Tran and Mike Tilden hosting a booth to engage with the young competitors. They distributed informational materials and shared insights about career opportunities within IBEW 1245, sparking interest among students eager to see how their current skills could lead to future careers in the trades.

The contest itself was designed to be a rigorous, fast-paced challenge. Each team was tasked with building a metal-framed bench and footstool with wooden slats—within a strict six-hour time limit. Contestants received their project designs and blueprints the morning of the competition, ensuring the experience was authentic, spontaneous, and focused on adaptability.

Beyond the fabrication challenge, students gained hands-on experience in problem-solving, collaboration,

and technical execution. Many participants left with a renewed passion for welding and fabrication, along with a sense of accomplishment. Some teams even completed their projects using PG&E welding trucks, and students also had the opportunity to tour PG&E's on-site training facilities

While not all teams were able to complete their builds within the time frame, the contest allowed them to bring their partially completed projects back to their schools to finish them in class—an extension of the learning experience that exemplifies the contest's educational value.

This year's event was organized as a senior project by Winters High School student Daniel Tejeda, who aimed to create a challenge that pushed participants to think critically while honing their technical skills. Teams were judged on precision, craftsmanship, and teamwork, reflecting the importance of applied learning in today's career technical education programs.

IBEW 1245 Business Representative Phuong Tran was inspired by the energy of the students, stating, "The interaction with the high school students participating in the welding competition was outstanding. Their energy and enthusiasm for the welding trade gave me hope that the future of our pipeline is in great hands. Hopefully, some of these kids will consider a career working at some of Local 1245's represented properties."

Kaycee King echoed that sentiment, adding, "Attending the WHS FFA Fabrication Contest was such a great experience—watching local youth come together and showcase their amazing talent and skills in welding and fabrication. It was also compelling to see the diversity of the teams, with boys and girls competing side by side. You could truly see the pride each student had in their work. Being there to represent IBEW 1245 and talk to them about potential career paths was exciting for them and meaningful for me. Representation is one of the best ways we can bridge the gap for women and young girls entering this industry and show that with drive and determination, anything is possible."

California

As we come to the end of the first quarter of 2025, Outside Line saw very little job growth, which is consistent with our historical norms. However, the second quarter should bring a significant call volume to 1245.

PG&E's target for 2025 consists of 330 miles for underground hardening, 200 miles of overhead hardening, 20 megabundles and a large budget for new business work. There will also be an increase of New Business work with the funding from SB-410.

In the Sierra division we have both Alvah and Intren filling in the void for H&M. Intren is currently running with 12 crews and will be looking to add eight more when the fire hardening and mega-bundle work drops between mid-April and the first part of May. Alvah has just started two crews in the Sierra Auburn yard and plans to add four more when the work gets released. Dars Cox was awarded another 30 miles of underground on the Apple Hill circuit in Camino. They have hired 20 new members and look to add 20 more in the next

couple of weeks. C&C will be providing the line side of this project. In the Humboldt division, Basin is coming in to replace H&M on the transmission work in Eureka. Currently, Basin has two crews working and anticipates the need for two more crews by mid-April. Outback will support Basin with civil work with 10 to 15 people. Wilson currently has five crews in the Humboldt division: two crews working in Clear Lake, two crews working in Willits, and one crew working in Eureka. They expect to maintain this workforce throughout the year.

Summit has added two new transmission crews this last month in their Redwood Valley yard. The south area has 2-line crews at the yard in Coarsegold, 3-line crews out of the Mariposa yard, and one heavy line crew in the Los Banos area.

In the North Valley, Par West is looking to add two more transmission crews to their Anderson yard. On the distribution side, they are currently staffing six crews and may possibly add four more when the mega-bundle starts. C&C currently has bids out in the North Valley on 50 miles of underground hardening. The hope is to have that secured in the first part of April. MGE Underground has an undergrounding project in the Lebec area, down south by the Grapevine, with one heavy line crew and 3 civil crews. This is a 3-year project with three phases and an end date of 2027. This project started in the beginning of 2024. Outsource continues to be the steady force in the Central Valley and in the Templeton area, performing tag work, reconductors as well as new business projects, currently with 12-line crews and 9 civil crews in the Central Valley, and 3-line crews and 4 civil crews working out of the Templeton yard.

With this hopeful outlook for the upcoming quarter and in anticipation of possible long hours away from home spent providing for our families, it is important that we maintain and promote the values of the IBEW membership. As IBEW members we take pride in the job being built right the first time. We take pride in our craftsmanship. and we leave a lasting impression of quality work with the customer. We arrive on time, ready and willing to work. We maintain a healthy and safe work environment free from drugs and alcohol. It is paramount that we prove to our customers the value of using IBEW members.

Let's stay safe, maintain our situational awareness, and be our brother's keeper.

The Fresno bi-monthly informational meetings continue to take place on the second Tuesday of every other month from 6pm to 8pm at Round Table Pizza at 5702 N. Nevada

T&D Power at the Walker River project outside of Yerington NV is moving forward with pads, foundations and the dog houses on the 120 KV sub. The steel for the switchgear will be installed when the crews return from the holiday break. There are approximately 90 members on the project at this point. There's been a delay ramping up on manpower due to environmental permitting issues.

Wilson Construction has been awarded SWIP north project, though there is still no word on the start date for this project. Wasatch continues to support NVE and Liberty Utilities on numerous projects, as well as supporting the utilities with supplemental dock work. Sturgeon has completed the fuse tamer project that spanned across NVE property in the northern part of the state in this quarter. Summit is still supporting the USA parkway project and the Switch Data Center project with Sub-Techs and Journeyman Lineman. Mountain Engineering is working on NVE property in Virginia City and is in the process of doing a line rebuild. They've also been doing numerous helicopter sets.

Accidents/Focus Items

The beginning of this year has seen a variety of incidents occur. The common factor, in a large majority of the inci-

IBEW 1245 Line Clearance Tree Trimmers

Setting Industry Standards

Pine Grove — 26-year IBEW 1245 member Juan Cervantes knows trees. A line clearance tree trimmer, he currently works as a Foreman for Arbor Works. Cervantes and his crew were downing a 105-foot Ponderosa Pine near Pine Grove that had grown within 15 feet of power lines.

"It has to be taken down," said Cervantes. "They're very concerned about it coming down," he said.

While Cervantes' traffic control crew managed oncoming vehicles, another crew helped pull brush.

Then his crew began the painstaking work of climbing and assessing strategies to remove the tree safely.

"My climber is going to be doing all the work above.," said Cervantes. "He is going to begin from the ground up. Once he gets into the higher part, he's going to cut small tops. We might be using a little bit of rigging on it just because of the power lines, but we'll see once he gets up there whether or not he's going to need some rigging. Then we will get our rigging equipment."

Business Representative and former Line Clearance Tree Trimmer Francisco "Cisco" Ferreyra accompanied the crew. "Pine Grove, California has a special place in my heart. It's

where I first became a Foreman in the Line Clearance industry. Foreman William "Billy" Underhill and Foreman Juan Cervantes were both my Foremen at one point in my career eighteen to nineteen years ago. I learned a lot from them," said Ferreyra.

He added, "This crew displayed their knowledge and expertise using various methods and climbing styles along with specialized equipment to get the job done safely. Back in the day, there weren't as many skilled, Journeymen Tree Arborists like Kaleb Fillmore and John Church. Most of the tree yards only had a few employees who could remove hazardous trees. Now, IBEW 1245 along with the JATC

is producing the most highly skilled and educated Journeymen Line Clearance Tree Trimmers in the industry, setting some of the highest standards the industry has ever seen!"

Asked if this is an unusual assign-

Building Record-Setting Towers in the Delta

Birds Landing Area, Rio Vista, CA —

Foreman Pete Tibbertsma — a 47-year IBEW 1245 member — had seen it all. That is until he was called out on a job by Michels Pacific Energy to demolish one of the tallest transmission towers in the United States and replace it with two brand new towers in the California Delta in Rio Vista.

"We've pulled a lot of towers, but this is our first demolition," said Tibbertsma.

A seasoned Outside Line journeyman lineman, Tibbertsma and his crew were charged with replacing the 520-foot transmission tower in Rio Vista with two new towers - 565 feet and 545 feet respectively. The enormous steel towers stand three quarters of a mile apart and are some of the tallest ET towers in the United States.

"The replacement became necessary when the bottom conductor got hit by a ship out in the middle of the Delta, so they needed to raise them up," said Tibbertsma. The work began in mid-July, 2024, and is expected to be completed in the next month or two. "All we have to do is pull new wire in, get it dead ended, and made up," he said.

Tibbertsma described his crew as the "shake down crew, saying, "We laid out all the steel for [the new towers]. There's a little under a million pounds of steel on the new tower and 336,000 bolts per tower."

According to Tibbertsma, the greatest challenges facing the crew were the soft

> ground and the wind. "Our 300-ton crane was 600 feet high; the water level was down 3½ feet. We had to mat it, put steel on top of mats, and deal with it sinking by moving back and forth," he said. "And the wind messed with us the whole job. Over 15-mile an hour winds. We use man baskets. With 15mile hour winds, we'd have to stop."

But the crews are well trained and prepared.

Bob Fields - with thirtyeight years' experience, twenty-eight of which are with the Union described his hands-on training. "There's lots of training...cranes kind of my specialty, but I run everything...and now they have crane

schools, and everybody's got to have a crane license," he said.

Tibbertsma stressed the importance of the knowledge passed down from the generations of linemen who came before him. "I've been doing this for forty-seven years, and I learned from old Linemen. I'm still talking to old Lineman. A friend of mine, Jake Snake, Salt Lake, he's eighty years old, and he taught me a lot about line work. I just learned from the old guys, and hopefully I've taught a lot of the younger guys how to do it," offered Tibbertsma.


As for safety protocols, "When I started in this business, there were no safety meetings. And then there were safety meetings every month, and then every week, and then every day, and then every tower," said Fields.

Journeyman Lineman Scott Huddleson declared, "Our members building these two record setting towers gives us bragging rights over the rest of the country.'

IBEW 1245 Senior Assistant Business Manager Ralph Armstrong, who oversees the Outside Line Department and is a seasoned journeyman lineman himself, added, "I've driven by the old towers hundreds of times, and they aren't easy to miss due to their size. This work is not easy, and good rigging is a priority. The skills these members must possess to perform this work safely is second to none and goes to show the kind of training they had to go through."

As for the Union, Fields was matter of fact. "It's made me a lot of money and given me good benefits, and I've worked on both sides," he said. "I wish more people would start on the other side (nonunion); then they'd know [the value of the union]."




Forty-seven year IBEW 1245 member Foreman Pete Tibbertsma heading up crew building two new ET Transmission Towers and demolishing a third in Rio

The host City of Roseville hailed the event as "the ultimate venue" for public power lineworkers to demonstrate their skills and safety knowledge, while competing for professional recognition. The City also invited vendors to display the latest tools of the trade, sponsored food trucks to supply nourishment, and provided a host of family events to keep the kids entertained. The two-day event went well into Saturday evening, finishing with a live concert.

Journeymen and apprentice line workers attended optional training courses on Friday, and on Saturday showcased their skills in front of their families, friends, coworkers, and the community. The Apprentice Competition included such events as Sidewalk Guy Installation, Obstacle Course, Hurtman Rescue, Lightning Arrester Jumper Replacement, and a Written Test. 



GRID OF THE FUTURE: Embracing Change

Vacaville - On Friday, April 25, 2025 labor, business and political leaders met for IBEW 1245's Grid of the Future conference at the Sunrise Center in Vacaville, Califor-

Three hundred sixty IBEW 1245 members, leaders, corporate partners and lobbyists participated, including three hundred IBEW 1245 rank and file members. Members met sisters and brothers from different properties and classifications; many had the opportunity to speak with the CEO's of their companies for the first

IBEW 1245 Business Manager Bob Dean welcomed the packed room, saying, "We built the grid. Our forefathers built it. We have to adapt and learn what we have to be in the future. You'll hear many perspectives today. Learn something you don't know and take it back to your yards."

IBEW 1245 senior leaders moderated panels of industry leaders, operations experts, and lobbyists.

PG&E CEO Patti Poppe, SMUD CEO & General Manager Paul Lau, and NV Energy's Senior Vice President Jesse Murray spoke to the challenges and threats faced by the energy sector. New technology, Artificial Intelligence (AI), data service centers, regionalization, the existential risks posed by wildfires, and cyber security were all discussed. Tariffs, supply chains, attacks on the Investor-Owned Utility (IOU) model and political and economic volatility were also addressed.

"The very foundations of tomorrow's energy are being laid right here," said IBEW 9th District Vice President Dave Reaves in his opening remarks.

"This is the most exciting time for our industry that any of us have ever experienced. There was a time when I thought we wouldn't be part of AI growth strategy in CA due to prices. What I've learned over last year is that we are in the mix. ... We're going to build transmission, generation resources to serve that load. The grid is working. {Though} wild fire risk is an existential threat, my forecast for the next 5 years is bright," said Poppe.

Lau noted, "The grid is going to transform, and CA is leading the nation." He posed key questions, including, "How do you work with the community and customers to transition from a one-way power flow to a two-way power flow and work with {emerging} technology and AI for the first time in utility history? ... CA will have six million EVs. ... The market

changing. Customers bringing change. How do we partner so that the grid works for the customer, the utility and the consumer?"

Murray described NV Enlink Nevada

project, a large-scale transmission infrastructure initiative designed to transport renewable energy across the state. "We're setting steel right now in northern Nevada, and building a Substation for two 500 KV transmission lines, stretching approximately 750 miles; Greenlink West-from Las Vegas to Reno and Greenlink Northconnect points east all the way to southern Nevada and Utah."

Rachel Koss, a partner at Adams Broadwell Joseph & Cardozo, stated, "There's tons of work to be done. Grid hardening to prevent wildfires; capacity upgrades for new business coming online; but it's expensive. There is tremendous political pressure to slow down the investment/spending. The PUC {in California} has slashed more than any other time, including for undergrounding and capacity upgrades." At the same time, heightened animosity toward Utilities from rate payers and in state legislatures is on the rise. It remains to be seen whether or not federal funds will flow.

Recruitment and training of the workforce with the skill set to meet demand and adapt to new technologies were recurring themes.

Panelists identified the biggest threats as the risk of wildfires, cyber security, and a series of legislative initiatives.

But, as Scott Wetch, a Partner at Actum and longtime lobbyist for IBEW declared, "The Good news is that you are members of best union in CA; one of the hardest working workforces; and you provide vital services." He thanked the Organizing Stewards in the room for being a force at the Capitol to push back against some of the legislative initiatives that threaten members' work and livelihoods.

Earl C. Duke Austin, Jr, the President and CEO of Quanta Services emphasized safety and embracing change. A 4th generation journeyman lineman, Austin leads Quanta Services, the single largest contracting firm in the United States with 65,000 employ-

Austin's advice to the IBEW workforce, "Don't sit on your hands and don't wait for things to change. Change it yourself. Don't look back. Prepare yourself for tomorrow. The more you prepare, the more you train, the smarter you get, the less issues you'll have on the other side. This state and this union are as innovative as any. Are you going to embrace it or not?"

There's no question that IBEW 1245 has been exercising leadership.

In 2023, after three separate attempts to regionalize energy had threatened to gut standards and safeguards for IBEW 124's membership, Dean spearheaded an effort to craft a new proposal for regionalization.

"Regionalization is about operations of the

grid," said Marc Joseph, Of counsel to Adams Broadwell Joseph & Cardozo. "The idea is to coordinate efforts in order to save money, improve reliability and reduce emissions. The challenge: getting utilities across the West with different perspectives together." At the request of Dean, Joseph delayed his retirement to convene a group of forty stakeholders from eleven states and two Canadian provinces and the California Independent System Operator (CAISO) to craft a proposal that safeguards the interests of IBEW's members. In 2024 the committee completed a onehundred-page proposal. They've written a bill that must be adopted by the legislature. "Just last week, we won a 17-0 vote in favor. We have another committee vote next week," he said.

Dean closed the conference by thanking all who participated and worked to put it together. He punctuated the day saying, "There are many perspectives at IBEW. We bring them together. The most important takeaway: the world is changing. Our job is to keep doing the work. We built the grid. We're going to keep building the grid."


