In order to provide adequate coverage for the upcoming winter storm season, the Company proposes, pursuant to Subsection 10.7(b) of the Clerical Agreement, to establish the following temporary shifts at the following headquarters and to solicit volunteers to staff them:

- Monday Friday, 7:30AM-4:00PM
- 2. Monday Friday, 8:00AM-4:30PM
- 3. Monday Friday, 8:30AM-5:00PM
- 4. Monday Friday, 9:00AM-5:30PM

## Sacramento 2730, San Jose, and Stockton will be offered:

- 1. Monday Friday, 8:00AM-4:30PM
- 2. Monday Friday, 8:30AM-5:00PM

The temporary shifts are expected to last between 1/3/2016 - 2/13/2016. The following number of temporary shifts will be offered:

With respect to staffing these shifts, the parties agree to the following:

Volunteers (not currently working in one of these shifts) will be solicited to fill these shifts, and shift changes will be awarded on the basis of seniority and by classification. The Company will not force employees onto this shift. In the event that the temporary shift changes prove unnecessary, the Company will give the employees the option of remaining in the temporary shift through the duration of the period. Should a volunteering employee's circumstances change such that it's no longer practical for them to remain in the temporary shift, the Company will allow them to revert to their original schedule. Finally, any prior time-off requests will be honored for employees who volunteer for the temporary shift change.

Upon 30 days written notice, either party may cancel this agreement.

This proposal has been discussed with Senior Assistant Business Manager, Jenny Marston.
