Dear Mr. Dean:

The Company and Union agreed in Letter Agreement 23-07 to explore utilization of IBEW Local 1245 for the installation of customer-owned isolation adapters (also referred to as meter collars) that sit between the utility electric meter and the customer's meter socket in PG&E's service territory to increase customer's resiliency and improve utility operations. Due to volume of work not meeting forecasted projections during the initially agreed upon Pilot period, the parties have agreed to extend the Pilot through March 31, 2025 as follows:

The parties identified multiple components of this work. Installation and removal of the utility electric meter has been identified as jurisdiction exclusive to IBEW Local 1245; however, installation of customer-owned isolation adapters, or other third party electrical isolation adapters is not work normally performed by IBEW Local 1245.

As part of the continued partnership, the Company and Union will participate in a pilot with a limited number of customer-owned isolation adapters, such as Tesla's Backup Switches. Work considered within the scope of this pilot may include the removal and reinstallation of the utility electric meter and installation, by an employee in one of the classifications listed below, of the customer-owned isolation adapter between the utility electric meter and the customer's meter socket. The scope of this work and the inclusion of the installation of customer-owned isolation adapters in this pilot shall not cause the performance of installation of customer-owned isolation adapters to become the jurisdiction of IBEW Local 1245. Only explicit agreement following this pilot will change the jurisdiction.

The Company and Union will participate in a pilot as follows:

- The pilot will conclude on March 31, 2025; however, the pilot may be extended by mutual written agreement.
- The following classifications will be included in the pilot at management's discretion:
 - Apprentice Metering Systems Technician (51508445)
 - Energy Diversion investigator (52232611)
 - Energy Diversion Specialist (52232612)
 - Meter Maintenance Person (50406798)
 - Metering Systems Technician (50010424)
 - Metering Technician Crew Leader (50010389)
 - PIO Electric Field Meterperson (50070800)
 - Unassigned Metering Systems Technician (50010425)
- Training will be provided to the employees included in the pilot.

Oversight Committee

The Company and Union shall each appoint up to three members to be part of an Oversight Committee. The Oversight Committee will attempt to resolve any issues that may arise regarding this Letter of Agreement within forty-five (45) days. Issues that the Oversight Committee cannot resolve will be subject to the party's grievance procedure. Subsection 102.3(a)(2) timelines will be waived for the forty-five (45) day period.

This proposal has been discussed with Senior Assistant Business Manager's Bob Gerstle and Anthony Brown.

Either Company or Union may cancel this agreement by providing the other party with 30 days' written notice.

This agreement cancels and supersedes Letter Agreement 23-07.
