Dear Mr. Dean:

The Company and Union met to discuss a joint interest in clarifying job duties for classifications in the Cable Splicer line of progression through training of the existing workforce and revision to the existing Apprentice Cable Splicer training program. Based on the aforementioned, the parties agree to the following:

- The Company commits to fill no less than six (6) Apprentice Cable Splicer positions in 2025. If development of the training curriculums, noted in Item No. 2 below, are completed by October 1, 2025, the Company will commit to fill no less than six (6) Apprentice Cable Splicer positions in 2026 and 2027. The parties agree the aforementioned date of curriculum completion may be extended by mutual written agreement.
- Subject Matter Expert (SME) team(s) will be created to develop training curriculums for current incumbents in classifications in the Cable Splicer line of progression, including Apprentice Cable Splicer. SME team(s) will focus on creating training curriculums to include, but not limited to, the following job duties:
 - a. SCADA Maintenance (KCF), including but not limited to:
 - i. Fiber/Communication Repair & Troubleshooting
 - ii. RTU Component Repair/Replacement
 - iii. Sensors
 - iv. Power Supply
 - v. Reinstall SCADA Units
 - vi. Dewatering Vaults
 - vii. Emergency Repair (e.g., fire, flood, earthquake)
 - b. Capital Upgrades Fiber (2CE)
 - c. Network Cable Replacement (56N)
 - d. Network Transformer & NP Replacement (2CC)
 - e. Vented Manhole Cover Replacement (2CD)
- 3. Once the training curriculums have been developed, current incumbents in the following classifications in the Cable Splicer line of progression will be trained to perform the job duties identified in Item No. 2.

- 4. The parties agree the job duties referenced in Item No. 2 are included in the job definitions for the classifications identified in Item No. 3.
- 5. IBEW recognizes classifications in the Cable Splicer line of progression will be trained to perform job duties at Training Centers and in the field by non-represented management employees (i.e., Training Instructors).

6. Oversight Committee

The Company and Union shall each appoint three members to be part of an Oversight Committee. The Oversight Committee will attempt to resolve any issues that may arise regarding this Letter of Agreement within forty-five (45) days. Issues that the Oversight Committee cannot resolve will be subject to the party's grievance procedure. Subsection 102.3(a)(2) timelines will be waived for the forty-five (45) day period.

The Company or Union may cancel this agreement by providing the other party with thirty (30) days written notice.

This proposal has been discussed with Senior Assistant Business Manager Bob Gerstle and Assistant Business Manager Roberto Balistreri.
