Dear Mr. McNally:

The October 27, 1999 cover letter to the General Negotiations Settlement provides for combination classifications of Credit Representative and Meter Reader, Service Representative and Meter Reader, and Meter Reader and Utility Clerk to remain in the Clerical Agreement, while the parties agreed to move the Meter Reader classification to the Physical Agreement.

The Company has reviewed the attached breakdown of duties of employees in combination classifications and determined that some employees in combination classifications have been exclusively (100%) or almost exclusively (99%) performing duties of one classification. The Company is therefore proposing that the following employees be reclassified into the appropriate classification:

Employees currently classified as Credit Rep and Meter Reader (2770):

None of these employees' wages will be adjusted, since Letter Agreement 95-39 provides that employees in combination classifications will receive the wage rate of the higher classification.

Employees reclassified as Credit Representatives will continue to be covered under the provisions of the Clerical Agreement while employees reclassified as Meter Reader will be covered under the provisions of the Physical Agreement. Employees remaining in combination classifications will continue to be covered by the Clerical Agreement.
