Dear Mr. McNally:

Pursuant to Title 3.5 of the Agreement, the Company proposes to modify the residency requirement for a Troubleman located at the Stockton Service Center for the following reason:

Jim Sheridan accepted and reported to a Troubleman position in Stockton on 4/13/99. Jim lives 40 minutes from the headquarters. When he accepted the position he had full intentions of moving to within 30 minutes from the headquarters. Both Union and Company were fully aware of his intentions.

On 4/24/99 Jim's wife suffered a major accident. As a result, Jim has had to modify their current home to make it more accessible to his wife. We have received medical documentation regarding Mrs. Sheridan that states: "it would not be in her best interest to make any changes in her living status. Since she has difficulty walking and performing normal, household tasks, she relies heavily on the modifications made to their present home, as well as on Jim's assistance. She also suffers a permanent residual of pain."

We believe that since this unfortunate situation developed after accepting and reporting to the Troubleman position, we should consider this a hardship and propose waiver of the 30 minute residency requirement.

This proposal has been reviewed with Business Representative Gary Hughes. Either the Company or Union may cancel this agreement with 30 days written notice.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
