Dear Mr. McNally:

William Maynard was awarded an Apprentice Fitter position in October 2000. Mr. Maynard has been Heavy Truck Driver since 6/19/1995 and prior to that he was a Utility Worker and Fieldman since 3/11/1985, which was the date of his hire.

Mr. Maynard has approached his Supervisor and expressed a concern about the cut in pay from a Heavy Truck Driver to an Apprentice Fitter. The Company proposes to minimize the financial impact on Mr. Maynard by paying him the top wage rate for an Apprentice Fitter (\$938.00) as he enters the Apprentice Fitter classification. The proposed salary treatment is similar to the treatment of a Fieldman or an Equipment Operator entering in an Apprentice Fitter position, as described in Exhibit VI of Section 600.1 of the Agreement revised July 1993 on page 10, note 2.

Mr. Maynard will not have subsequent bids on Fitter vacancies considered under Section 205.7(b) until he has accrued 24 months as an Apprentice Fitter. In addition, Mr. Maynard will not be considered for automatic progression to Unassigned Fitter under the provisions of the Master Apprentice Agreement until he has accrued 30 months as an Apprentice Fitter.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided below and return one executed copy of this letter to the Company.
