Dear Mr. Zimmerman:

Pursuant to Subsection 204.4 (b) of the Physical Agreement, the Company proposes to utilize journeyman and above in the Lineman line of progression on a temporary basis to be Field Instructors as recommended by the Lineman 2000 Committee. Field Instructors will work closely with the Field Coordinators in the training of Apprentice Linemen. Field Instructors will be considered an exempt position.

FIELD INSTRUCTOR

Description:

This position will provide field instruction to Apprentice Linemen in a geographical area. The Field Instructor will train Apprentice Linemen on "live line" and "rubber glove" work methods under actual field conditions on workload drawn from a local area. The Field Instructor will also evaluate, document and report apprentice's performance on a timely basis and schedule certification performance exercises for the apprentice.

Qualifications:

- Journeyman Lineman level or higher (minimum 2 years of experience as a Journeyman Lineman).
- Successful completion of the one week Field Instructor Qualification Program.
- Must have leadership skills, good safety record, and be certified in Rubber Gloving.

Selection:

- The Lineman 2000 Committee will approve the list of volunteer candidates for this position.
- Management will select the Field Instructor from the approved list.

Training:

- Field Instructor Qualification Program one week course.
- Minimum of 15 Trainers will be instructed initially.
- Lineman 2000 Committee will review and approve the Field Instructor Qualification Program.

Administration:

- These positions will be filled only on a time card basis and will be temporary assignments.
- These positions will be paid 5% above 0740 Electric Crew Foreman for Title 200 employees and 5% above 0650 Subforeman A for Title 300 employees.
- Employees in these positions still can be called out or assigned overtime if available in their base classification.
- These positions will continue to report to their respective Supervisors, however, they will be required to work closely with the Training Coordinator in their geographical area.
