Dear Mr. Zimmerman:

Company proposes to amend Title 14 of the Clerical Agreement to allow Call Center employees on the attached list, and any other Call Center employees who meet the criteria, who will not obtain regular status until November and December of 2001, the opportunity to defer their floating holidays to 2002.

These floating holidays will administratively be converted to personal business with pay and must be taken off by May 31, 2002. From a scheduling standpoint, deferred floating holidays will still be considered floating holidays and the scheduling of such time shall be in accordance with the provisions of Section 14.3.


