Dear Mr. Zimmerman:

For the past eight years, Larry Gonzales, Troubleman, Merced, has been working with Merced County, volunteering his time to teach a summer youth program. The youths, ages 14-17, install sidewalks and install and maintain landscaping in the city of Planada. This year, the program will run from June 17, 2002 to August 2, 2002.

In the past, Mr. Gonzales worked a late shift in the summer, which allowed him to perform his volunteer work in the mornings. However, this year his work group is under a different overtime agreement that fixes the shift hours at 9:00 a.m. to 5:30 p.m. year around. Unfortunately for Mr. Gonzales and the summer youth program, this shift conflicts with his volunteer work. Mr. Gonzales is willing to use his vacation days to continue to volunteer for the program, but his total allotment of vacation hours will be used up very quickly if taken in eight-hour increments.

The Company proposes to make every effort to accommodate the following vacation schedule for Mr. Gonzales to continue with the summer youth program subject to business needs. This proposal allows for Mr. Gonzales to take more than 16 hours of incremental vacation as provided in Section 111.16 of the Agreement during the period of June 17 through August 2, 2002.
