LETTER AGREEMENT

Dear Mr. Zimmerman:

Mr. Manual Garcia, Apprentice Meter Systems Technician, headquartered in Woodland, requests a temporary hardship transfer due to his mother's medical condition. While this situation does not meet the criteria for a hardship transfer under the provisions of Section 205.17, the Company proposes to temporarily assign Mr. Garcia to the Metering Services Department in Santa Rosa, for a period not to exceed 90 days, in accordance with the provisions of Section 205.19.

For the duration of this assignment, Mr. Garcia will be assigned to the Santa Rosa headquarters, which will be considered his regular headquarters for the purposes of Section 202.19, and as such, no expenses are owed Mr. Garcia.

This is a temporary transfer and it will not count towards Mr. Garcia's ability to move once during his apprenticeship in accordance with the Master Apprenticeship Agreement, Section H.

This agreement will end 90 days from the date of the signed agreement, or at such time that Mr. Garcia's personal situation resolves itself, or if operational need requires his return to his base headquarters in Woodland. In addition, either party may cancel this agreement with two weeks' notice.

This proposal has been discussed with the Business Representatives Darryl Norris and Larry Pierce who are in accord.
