Dear Mr. Zimmerman:

Company proposes pursuant to Subsection 205.19 of the Agreement to award a System Operator vacancy (JV21593) in Bakersfield to "E" bidder Brian Lee Davis.

Letter Agreement R1-98-16-PGE provides a specific sequence for filling Journeyman Operator vacancies. The provisions of P2, P3, and P4 of the Agreement have been exhausted. Item P5 then requires that the Company fill the vacancy with the Unassigned Journeyman Operator with the least service in the Bidding Unit. The three Unassigned Journeyman Operators in the Bidding Unit are:

Adam Kincade Daniel Jackson Unassigned Operator, Midway Unassigned Operator, Fresno

DOH 04/16/01 (Critical Class)

DOH 02/24/86

One currently holds a critical classification designation and is not eligible for the position. The other two have declined to submit bids for the position.

In lieu of requiring the least senior Unassigned Journeyman Operator to accept the position, the Company proposes to appoint Brian Lee Davis to the vacancy. He previously held a System Operator position with PG&E, is fully qualified, and desires the position.
