Dear Mr. Zimmerman:

It has come to the attention of the Joint Apprentice and Training Committee that following implementation of Letter Agreement R1-01-52, which established the Physical Assessment requirement for the Apprentice Lineman classification, not all parties were clear on the applicability of the requirement. This resulted in apprentices being placed into the classification without meeting the requirements as set forth in the Letter Agreement.

In accordance with 205.19 of the Physical Agreement, the JATC proposes to grandfather the 40 incumbents (see attached list) who entered the program without meeting the PIA requirements. They will not be required to successfully complete the assessment. In addition, the JATC has communicated that effective immediately all placements are required to successfully complete the PIA prior to being tagged into a position.

The JATC also recommends that any similarly situated employees inadvertently absent from the attached list be covered by this Agreement. Any additions identified will be communicated to the Union.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
