Dear Mr. Zimmerman:

In Letter Agreement 97-139, Section 4, the Company and Union agreed to provide both initial and replacement uniforms to Firefighters and Fire Captains at the Diablo Canyon Power Plant. To accomplish this, employees were given a sum of \$532 each January to purchase uniform replacements. They were required to submit receipts by the end of the year for the purchases and were taxed on any of the \$532 sum that was not spent. It has come to our attention that under IRS guidelines, this might not be an acceptable method of payment.

Therefore, the Company proposes that, on an annual basis, employees submit a form to the Company requesting replacement uniform pieces; and the Company will purchase them directly. The maximum dollar amount for replacement of eligible uniform clothing will be raised to \$550.

Additionally, Company proposes that a hooded sweatshirt and leather belt be added to the list of uniform clothing that is eligible for annual replacement and a jumpsuit can be substituted for 1 pair of dress pants and 1 dress shirt. at the employee's option.

This proposal has been reviewed with the local Business Representative.

If agreed to, this change will be effective on January 1, 2006.
