Dear Mr. Dalzell:

The Company is sponsoring a Habitat for Humanity Project to help rebuild residences destroyed by Hurricane Katrina. This event is scheduled from May 11–16, 2008. The Company is proposing to select four employees to participate in the project. All employees will be invited to apply by submitting a written statement. The winners will be selected by a panel, which will include representatives from the ESC, IBEW and Habitat for Humanity. All travel, housing and meal expenses will be paid by PG&E. Employees will be paid by the Company as personal business with pay and will not be charged vacation. No contractual provisions (overtime, travel time, etc.) will apply during this volunteer effort. Employees will be covered by Worker's Compensation while participating in this Company-sponsored volunteer project. All of the existing rules of Worker's Compensation will apply.

This agreement is without precedent and cannot be cited in subsequent proceedings between the parties other than to enforce this agreement.

Habitat provides lodging and meals while on site. PG&E will provide company paid time off, roundtrip airfare from a major airport to Biloxi, and other reasonable related expenses.
