Dear Mr. Dalzell:

The Company proposes to cancel and supersede Letter Agreement 05-10-PGE with the following. The change from Letter Agreement 05-10-PGE is a change in the per diem amount from \$99 to the per diem amount allowed by the Internal Revenue Service (IRS), as indicated on the General Services Administration website (www.gsa.gov).

Humboldt Bay Power Plant has occasional need to hire additional Radiation Protection Specialists. Because of the specialized nature of this work, it is sometimes difficult to attract workers for short-term work assignments without the payment of per diem and reimbursement for travel expenses. Therefore, Company proposes to hire Radiation Protection Specialists as temporary additional employees. The provisions of Title 106, 205, and 206 of the Agreement shall not apply to employees in these positions. The provisions of Section 4.4 shall be exercised within five (5) calendar days from receipt of Union's request. Per Diem and travel shall be paid as follows:

Per Diem: Current amount allowed by the IRS per day, as indicated on the General Services Administration website, upon meeting the IRS per diem requirement.

Travel:

Distance Traveled to HBPP	Reimbursement
< 75 miles	\$0
75 to 200 miles	60
201 to 500 miles	125
501 to 750 miles	250
751 to 1000 miles	350
> 1000 miles	500

This agreement may be cancelled by either party with at least 30 days written notice. The local IBEW Business Representative will be notified prior to exercising this Letter of Agreement.

This proposal has been discussed with IBEW Business Representative Roy Runnings.
