Dear Mr. Dalzell:

Company proposes to cancel and supersede Letter of Agreement 10-12 with the following modified language.

Pursuant to Subsection 306.10 of the Agreement, Company proposes to place Dennis Williams in a Title 300 General Construction Installer position. Mr. Williams is a Title 300 Apprentice Equipment Mechanic who is being removed from his current apprentice classification under the provisions of the Master Apprenticeship Agreement.

Since Mr. Williams is not in a Meter Reading position nor has he been impacted by AMI/SmartMeter™ technology, he will not be entitled to any Workforce Transition Benefits or any other contractual provisions under Letter of Agreement 08-19-PGE. Mr. Williams has passed the Physical Test Battery. This agreement does not alter the current bid rights or status of Mr. Williams. In the event that Mr. Williams is still in the GC Installer position and such position is cancelled at the end of the SmartMeter™ project, he will receive Title 306 demotion rights.

This proposal will commence upon the signing of this agreement. This proposal has been discussed with IBEW Business Representatives Joe Osterlund and Mike Saner.
