Dear Mr. Dalzell:

The parties have discussed issues regarding HH T300 GC Installers inspecting Abase adapters and have agreed to the following:

- T300s Installers will be trained to inspect Abase adapters on single or network phase, self-contained electric meters. This will include an inspection of the meter, Abase adaptor and condition of associated wiring. Any indications of an issue will be referred to the appropriate field employee in the Metering LOP for response.
- They will only be performing meter inspections and no adaptor exchanges are allowed; the inspection of meter and socket is considered part of their normal job duties.
- The majority of the work will be located in the San Francisco, San Jose and Oakland/East Bay areas.
- Approximately 30 - 40 HH T300 GC Installers will be trained and assigned these duties in the San Francisco, San Jose and Oakland/East Bay areas. .
- Effective upon execution of this agreement, all classifications in the Metering Lines of Progression will be offered overtime but no less than 20% overtime in the service territory/headquarters where the HH T300 GC Installers are performing the work identified.
- The Company estimates approximately 45,000 Abase adaptor inspections / replacements and given other workload commitments, the specific inspections referred to in this agreement are expected be completed by June 30, 2014. The Company and Union agree to meet and confer should any issues arise out of this agreement.
- Upon Union request the Company shall provide to Union the location and number of HH T300 GC Installers conducting Abase inspections.
- Either the Company or Union may cancel this agreement by providing 60 days advance written notice.
