Gentlemen:

This letter supersedes our letter of September 12, 1966 on the same subject.

During the recent negotiations, Company informed Union that Panoche Substation would become automatic, and that Los Banos Substation would be manned; that Wilson Substation would become automatic, and that Distribution Operators would be employed at Merced. It is expected that the Merced operation will begin in March of 1967 and that Los Banos will be manned in January of 1967. The following classifications will be established at each of these locations:

Attached is a list of the employees who will be affected by these changes showing their employment date, present classification, and present classification seniority date.

Company will reclassify Mr. M. E. Wright from Operating Subforeman (Panoche) to Operating Subforeman (Los Banos) under the provisions of Section 206.4(a) of the Agreement and proposes the following under the provisions of Section 206.1(e):

1. Reclassify Mr. H. G. Knutsen to Distribution Operator at Merced. Mr. Knutsen is the senior employee involved and has the greatest knowledge of the distribution area.
