Dear Mr. Dalzell:

Recently the Maintenance Department at Diablo Canyon Power Plant made a proposal to amend the vacation scheduling language in Section 111.13 (a) of the Physical Agreement. The proposed language change would allow for the first round of vacation sign-ups to be completed earlier and include the month of April in the first sign-up period. This proposed change will allow the Maintenance Department to better account for approved vacations when scheduling routine work during the first part of the year, improving operational efficiency. The proposed language is as follows:

#### **111.13 SCHEDULING**

(a) An employee desiring to use vacation during the months of January, February, March, and April shall indicate a choice of vacation periods during the months of October and November of the preceding year. Company shall post on appropriate bulletin boards in each headquarters a special sign-up schedule for this purpose beginning October 1. The final approved vacation for this sign-up period shall be posted no later than December 1.

During the first week of each year Company shall post on appropriate bulletin boards another vacation schedule sign-up in each department in each headquarters where employees shall designate their choice of vacation periods for the months of May through December for that year. The final approved vacation for this sign-up period shall be posted no later than March 15 on the appropriate headquarters' bulletin boards.

This proposal has been discussed with IBEW Business Representative Patrick Duffy and Senior Assistant Business Manager Bob Dean.

Either party may cancel this agreement by providing the other party with 30 days' written notice of cancellation.
