Gentlemen:

This letter agreement replaces our proposals to you dated October 15, 1965 and March 3, 1967 on the same subject.

Company will eliminate the classification of Mechanic in the Electric Maintenance Department in Sacramento which is presently being utilized to perform tool repair functions for the Division. In its stead, Company will establish an appropriate classification in the Sacramento Garage Department.

Company proposes, under the provisions of Subsection 206.1(e), to offer Mr. Harry F. Louch, the incumbent Mechanic, an opportunity to qualify for training as an Apprentice Equipment Mechanic in the following manner:

> Mr. Louch will have an opportunity to meet the entrance requirements for the Apprentice Equipment Mechanic classiat any time during the period ending 30 days following the date he is informed of this agreement between Company and Union.

If, during such 30-day period, Mr. Louch successfully meets the entrance requirements, he shall be reclassified to Apprentice Equipment Mechanic at the 24 months' step. Six months subsequent to that date, he would automatically progress to the 30-month top rate of the classification. However, he will not be deemed qualified for bidding under Subsection 205.7(b) of the Agreement or be eligible for progression to journeyman until he has been in the Apprentice Equipment Mechanic classification for a minimum of two years. Mr. Louch will be offered the apprenticeship training program for Apprentice Equipment Mechanics and when qualified, following such two-year period, his progression in the Garage Department shall be considered in the normal manner.

Should Mr. Louch fail to qualify within the 30-day period, he will be reclassified at the end of such period to Routine Mechanic in the Sacramento Garage and will be paid the then current wage rate of such classification.
